1. EVALUATION & ORDER AWARD:

- Offer shall be evaluated on “**overall lowest offer basis**” and the items are **NOT SPLITABLE**.

2. PRE-QUALIFICATION CRITERIA:

- a) The bidder shall be a manufacturer or a dealer of Industrial Air Compressors. In case of a dealer, the bidder shall produce valid authorization letter issued by a manufacturer.
- b) The bidder must have prior experience in the supply of Industrial Air Compressors to any industry PSU/Govt. during last 10 years. Copies of POs shall be submitted to substantiate the same.

3. Other Technical Terms & Conditions:

Specification for Industrial Air Compressor Unit is as below:

- i. Air Compressor-Oil free, Air cooled, Reciprocating type compressor.
- ii. No. of stages- Single stage
- iii. Motor- 3HP
- iv. Electrical Supply: 415 VAC, 3 Phase 50 Hz.
- v. Working Pressure: 8 KG/SQ.CM
- vi. Piston Displacement CFM 16 cfm
- vii. Receiver Capacity -114 Ltr.
- viii. Accessories- Receiver, Enclosed Belt Guard, Motor Pulley, V-Belt, Pressure Gauge, Pressure Regulator, Service Valve, Drain Cock, Safety Valve, Flame proof Motor & Starter.

Special Note:

- i. The item shall be manufactured as per applicable codes and standards of the latest edition.
- ii. The compressor must be electrically driven and capable of delivering air pressure upto 8 kg/cm² with atmospheric air as suction.
- iii. (a) The compressor must be portable tank mounted and with a base frame.
(b) The GA drawing of the offered compressor must be submitted at the time of bidding.
(c) The Flameproof Items and Fittings shall be tested By DGMS/ CIMFR and approved by PESO / CCOE and Certificates to be enclosed with the offer. Offer may get technically rejected if these documents are not submitted along with offer.
- iv. Noise level not to exceed 65 dB(A).
- v. Manufacturing test certificate should be furnished along with the offer.
- vi. Materials shall be delivered at NRL Siliguri Marketing Terminal (SMT) Site, Siliguri within 02 (Two) Months from the date of PO.

SPECIAL NOTE TO THE BIDDERS:

- a) NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credentials against PQC. Authentication may be verified with the issuing authorities by way of direct communication to NRL over official e-mail IDs/Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid.
- b) The requirement of Prior Turnover & Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.
- c) Both Manufacturer and their Authorized dealer / channel partner cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- d) **Price preference for MSE Bidder:** The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader.
