NOTICE INVITING TENDER

Two parts bid **ONLINE (E-tender)** item rate offers requested from competent contractors for following work:

Name of Work:	AMC for Insulation at Refinery & NRMT
Tender No. & Date :	OC19000284-BOR dated 06.02.2019
Due Date & Time of Submission :	Closing of bidding : On 27.02.2019 before 11:00 hrs. Opening of bid : On 28.02.2019 after 11:00 hrs.
Earnest Money Deposit :	Rs. 80,000.00 (EMD applicable for all bidders including MSE)
Contract Period:	12 months from date of handling over of site with a provision for extension by another 12 months.

BRIEF SCOPE OF WORK: As detailed in Tender Document, Special Terms & Conditions & BOQ.

BID QUALIFICATION CRITERIA:

- The intending bidders for above tender should meet the qualifications as given below:
Past Experience of having successfully completed similar works during last 10 years ending last month should be either of the following:
 - Three similar completed works costing not less than **Rs. 49.07** Lakhs each, or
 - Two similar completed works costing not less than **Rs. 65.43** Lakhs each, or
 - One similar completed work costing **Rs. 81.79** Lakhs.

***Similar Works :** *The bidders should have experience in “Insulation Works in industry”.*

- Note:**
- Bidders should duly seal & sign the integrity Pact. Bidder's failure to return the Integrity pact duly signed shall result in the bid not being considered for evaluation.
 - The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and/ or part thereof
 - TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate etc.) shall form the basis for considering experience and value of work executed under the private organization.
- Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least **Rs. 49.07 lakhs** . The bidder must submit copy (ies) financial documents – Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.

SPECIAL NOTE TO THE BIDDERS:

- The relaxation of Prior Turnover and Prior Experience will not be applicable for Micro and Small Enterprise (MSE) or Startup bidder for this tender.**
- Public Procurement Policy is applicable for supply of goods and services. Works contract is not covered under the Public Procurement Policy for MSME. Therefore, MSE benefit will not be applicable for this tender.**

OTHER REQUIREMENT:

It is to be noted that experience as main contractor will only be taken cognizance of for the purpose of assessing qualifying criteria. However, authorized sub-contractors under principal contractors can also be considered provided their works completion certificate is issued by the client organization in case of job executed elsewhere under PSUs, limited companies, Government Departments, Quasi government and autonomous bodies. However, in case of sub-contractors under contractors engaged by NRL, the works completion certificate issued by the main contractor will also be acceptable provided the same is endorsed in original by Engineer-in-charge of NRL in terms of job description and value.

For accepting experience as sub-contractor(s) or contractors under Private Organizations, in addition to the requisite certificates (letter of award and job completion certificate etc.)TDS certificate issued by principal contractor / private organization shall form the basis for considering experience and value of work executed.

3. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
 - i. Provident Fund Registration Number.
 - ii. ESI registration number.
 - iii. Income Tax PAN Number.
 - iv. GST Registration Number.
4. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. **Accordingly, the bidder shall submit a self declaration as per format enclosed with Tender Document.** It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
