Pre-Qualification Criteria (PQC):

- a. Vendor should have proven track record and should be in the cooling water treatment business of refineries/ petrochemical industries for similar treatment for **last 5 years**.
- b. Vendor should produce documentary evidence of handling cooling water treatment not less than NRL's existing capacity.

c. The cooling water treatment in at least **one refinery should be successfully in operation for more than Four years**. A detailed client list with address and name of contact person along with client facilities should also be provided.

In addition to above contractor should also meet the qualifications regarding Past Experience of having successfully completed similar works in last ten years ending last day of the month, preceding the month in which bids are invited should be either of the following.

1. Three similar works costing not less than Rs. 52.20 Lakhs.
2. Two similar works costing not less than Rs. 69.60 Lakhs.
3. One similar successfully completed jobs Rs. 87.00 Lakhs.

The value of past experience shall be adjusted at a simple rate of **07%** for every completed year ending last day of the month, proceeding the month in which bids are invited.
