- ii) This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.

- iv) Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.
- v) Subsequent Corrigendum/Addendum (if any) shall be uploaded in CPP Portal only.
- 3. Agencies submitting their bids shall not be on Holiday list of NRL or any other Oil PSE. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

### 4. **PRE-QUALIFICATION CRITERIA (PQC):**

- i. Bidder shall be ISO 9001 certified. Copy of valid certificate shall be submitted as proof of the same.
- ii. Bidder shall have supplied Welded Plate heat exchangers as per API 662 to crude oil refineries within 10 years to be reckoned from final bid due date of this tender. Copies of purchase orders/ Inspection release notes/relevant supporting documents to be submitted as proof of having supplied the same.

- e) Integrity Pact duly sealed & signed.
- f) Un-priced Price Schedule for list of Recommended Commissioning Spares (if any) and Recommended Special Tools & tackles (if any) (with prices left blank).
- g) Un-priced Price Schedule for list of Recommended 02 years O&M spares (with prices left blank). (Note: Price for 2 years O&M spares shall not be considered for evaluation)
- h) In case of Micro & Small Enterprise (MSE), relevant documents (i.e. EM-2 certificate /Udyog Aadhar Memorandum and Indemnity Bond in Rs.100/- stamp papers as per format enclosed) as per clause no. 7 of NIT below.
- i) Vendor Details as per Format enclosed.

### 9. **GENERAL**:

- i) Bidder should not be under liquidation, court receivership or similar proceedings. Bidder to submit the self-certificate in this regard.
- ii) Consortium/Joint venture bids shall not be accepted.
- iii) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.

- iv) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- v) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
