[The value of past experience will be adjusted at a simple rate of **7%** for every completed year ending last day of the month proceeding the month in which bids are invited]

B. Financial Criteria:

<u>AVERAGE ANNUAL TURNOVER</u> in at least one of the preceding three financial years should be equal to **Rs. 10.20 Lakhs**.
