

Expression of Interest (EOI) to identify prospective Distributors/Dealers for setting up a LPG bottling plant utilizing bulk LPG produced at NRL's refinery at Numaligarh in Golaghat District of Assam

Numaligarh Refinery Limited(NRL) intends to invite Expression of Interest (EOI) from interested Domestic/International organizations/companies to build own and operate (BOO) LPG bottling plant within a radius of 50 KM of Guwahati city.

1. Background :-

NRL has embarked on a major integrated Refinery Expansion Project to triple its capacity from 3 MMTPA to 9 MMTPA with estimated capex outlay of Rs. 28,000 crores. The project also includes setting up of a Crude Oil Import Terminal at Pardeep Port in Odisha and laying of about 1640 KM of pipeline for transportation of imported Crude Oil to Numaligarh. The project is scheduled to commission by early 2025.

Post expansion, LPG production in NRL shall be approx. 500 TMTPA . NRL shall have it own LPG bottling plant of capacity 120 TMTPA at Dabi Dubi in Golaghat district of Assam where bulk LPG will be fed through pipeline from the refinery.

NRL's proposed POL terminal and bottling plant at Singhimari

NRL is planning to build one POL (Petroleum OIL & Lubricant) terminal at a place called Singhimari near Guwahati city over a plot of land measuring approx. 250 bighas. The capacity of the proposed terminal is expected to be 0.7 MMTPA. There is a provision to build one LPG bottling plant of capacity 60 TMTPA beside the POL terminal.

Bulk LPG will have to be transported from NRL LPG plant located in Dabidubi to the proposed bottling plant through NRL's registered transporters.

3. Objective of this EOI

- This EOI is floated to identify prospective agencies to build own and operate (BOO) LPG bottling plant at NRL's identified land or land provided by agencies within 50 KM radius of Guwahati city, Assam for at least 25 years.
- II. Bottling assistance required for approximately 60 TMT of LPG annually by operating in a double shift. However, initially the quantity will be less and will gradually increase depending upon the requirement, this quantity may vary over the years. The bulk LPG to be supplied from NRLs' LPG terminal in LPG bullets located in Dabidubi.
- ill. Applicants should meet the below mentioned criteria under all the three categories i.e. Experience, Infrastructure and Financial as on the closing date of the EOI.

4. Land selection for the proposed bottling plant

Interested agencies can select any one of the following options,

A. OPTION 1:-

- NRL's own land located at Singhimari Village, Hajo- Amingaon Road, Hajo Revenue Circle, Dist.: Kamrup, Assam, Pin Code: 781104
- B. OPTION 2:-



- Bidder to construct the bottling plant on their own or leased land within a radius of 50 KM of Guwahati city.
- C. OPTION 3:-
- Both the above options are acceptable

Assurance to arrange suitable land(within 50 km radius of Guwahati) will suffice for option B & C ./ Area of land for B & C /approachable from highway

5. Facilities to be developed as per relevant OISD and PESO guidelines with all the statutory requirements (Capacity of the bottling plant is 60 TMTPA)

- Bidders responsibility will commence from unloading of bulk LPG
- Storage facility of the bulk LPG received.
- Automatic Carousal system
- Conveyor system
- Pipelines for LPG/water/air
- Fire fighting facility fire pump house , hydrant lines/DG set
- Fire control system
- Water Tanks
- Complete Electrical system (transformer/substation etc.)
- Plant and area lighting
- LPG Pumps/LPG compressors /Pneumatic Control
- Cylinder unloading shed
- Cylinder loading shed
- Cylinder storage area shed
- Security, admin & amenities area
- Control room /inspection platform
- Parking area

6. End to end operation and maintenance of LPG bottling plant of capacity 60 TMTPA

- Trained manpower for operation and maintenance of the plant
- Manpower for loading and unloading of cylinders
- Bottling of cylinders (type of cylinders to be bottled are $14.2~{\rm kg}$, $19~{\rm kg}$, $5~{\rm kg}$, $40~{\rm kg}$, industrial type)
- Mandatory safety checking of the cylinders
- Repair and maintenance of the plant

7. Requirements of the Applicants:

- A. <u>Experience:</u> With respect to experience, Applicants meeting any of the following criteria are qualified:
 - Parties having at least one LPG Bottling Plant in operation in India.

OR

II. Parties who have undertaken LPG Bottling operation in their Plant any time during last 10 years in India.

OR

III. Parties having at least one LPG/Propane/Butane/import terminals in India.



IV. Parties having Global experience in owning and operating LPG Bottling Plant with registered office in India.

OR

V. Parties having Global/India experience of operating plants/terminals of LPG/Petroleum/Petrochemicals/Chemicals for at least one year in India or abroad during last 10 years with registered office in India.

B. Financial:

- The Applicant should have financial capability to construct the LPG Bottling Plant and is required to submit Audited Balance Sheets including Profit & Loss A/Cs, Income Tax Returns for the past 3 years and a Solvency Certificate from Bank as proof for financial capability.
- II. The average Annual Turnover of the Applicant shall be equal or more than Rs. 60 crore during the 3 immediately preceding financial years from date of issue of this bidding document.
- III. The applicant shall have positive net worth for the immediately preceding financial year as per the latest audited report.
- IV. The working capital: The bidder must have a minimum working capital of Rs. 20 crore as per immediate preceding financial year audited annual report.

8. Submission of EOI:

- Interested parties are required to submit information complete in all respects as per the format (Annexure-A) in sealed envelope.

- V. Applicant's signature on the documents is considered as total acceptance of the terms and conditions and hence "acceptance" need not be mentioned on each page of the EOI.

- III. The EOI can be cancelled by NRL without assigning any reason.
