BRIEF SCOPE OF WORK: As detailed in Tender Document, Special Terms & Conditions & BOQ.

## **BID QUALIFICATION CRITERIA:**

- 1. The bidder must have Experiences of executing contract value of <u>similar work\*</u> completed during last 10 years ending last month i.e. 28.02.2018 as follows:
  - One completed similar work costing not less than **Rs.24.81 lakhs**, or
  - Two completed similar works costing not less than **Rs.19.85 lakhs** each, or
  - Three completed similar works costing not less than **Rs.14.89 Lakhs** each.

#### \*Similar Works: Pre-Qualification criteria - Technical:

- i. Bidder shall have experience of executing structural steel plate fabrication /repairing job in Confined Space. This experience shall be substantiated with documentary evidence in form of PO & completion certificate.
- ii. Bidder shall have authorization/approval of State Legal Metrology Dept. to carry out repairing job of hydrocarbon tanks. Requisite documents shall be submitted to substantiate the same in the bid itself; otherwise the bid is liable for rejection.

#### Note:

- (i) The bidder must submit copy (ies) of relevant Work Order(s) and Completion Certificate(s) along with the un-priced bid in support of the above criteria. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and/ or part thereof (ending last day of the month i.e. 28.02.2018).
- (ii) TDS certificate in addition to certificate issued by principal contractor/private organization (letter of award and job completion certificate etc.) shall from the basis for considering experience and value of work executed under the private organization.
- 2. Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least Rs. 14.89 lacs. The bidder must submit copy(ies) financial documents Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.

- 3. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
  - i. Provident Fund Registration Number.
  - ii. ESI registration number.
  - iii. Income Tax PAN Number.
  - iv. GST Registration Number.
- 4. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.
- 5. Bidder should duly **seal & sign the Integrity Pact (Annexure C)**. Bidder's failure to return the Integrity Pact duly signed shall result in the bid not being considered for evaluation.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
