	In case any Bidder does not attend the pre-bid meeting, it shall be understood that the Bidder has a clear understanding of the Pre-Qualification Criteria, Scope of Work and all other Terms and Conditions of the Tender document and does not have any comment / deviation to the requirement of tender document.

PRE-QUALIFICATION CRITERIA:

A. CATEGORY OF BIDDER: Bidder shall be OEM or OEM's partner or Authorized representative/System integrator for the offered main items (i.e., Bollard barrier, Boom barrier, CCTV items (Camera, Server system and software (VMS)), Network Switches). If the bidder is not OEM, bidder shall submit authorization certificate from the OEM of the offered respective main item.

B. Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which the original bid due date falls, should be either of the following:

- **One** similar work costing not less than **Rs.108.37 Lakhs[#]**, or
- **Two** similar works costing not less than **Rs.86.69 Lakhs[#] each**, or
- **Three** similar works costing not less than **Rs.65.02 Lakhs[#] each**.

[#] The above values are exclusive of GST & Post Commissioning Expenditure i.e., Post SAT CAMC Part.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which the original bid due date falls.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:** **Similar job means** "Supply, installation & commissioning of Access Control System or IP Based CCTV System or combined job of Access Control & IP Based CCTV System in any Hydrocarbon Industries (Oil Refinery/Terminals /Gas processing plants/ Cross country pipe line (Hydro Carbon))/ Petrochemicals, in India."

Bidder to submit the following supporting documents for the compliance:

- i. Copy of purchase/work order/ agreement copy (containing the job description, item details, work order no., date of order, total ordered value) awarded in the name of bidder by client.
- ii. Copy of certificate/ minutes of meeting/ commission report on successful completion of job, by/ with the client mentioning the PO No., Job Description, PO value, Final executed value, Completion date etc.

C. AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs.65.02 Lakhs [#].

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers "or" certification of annual turnovers for the last three financial years from a registered chartered accountant firm. Last three financial years mentioned above refers to immediate three preceding financial years wherever the last bid submission date is after 31st December. In case of tenders having last bid submission date up to 31st December and audited / CA certified turnover documents of the preceding financial year is not available, the audited / CA certified turnover documents of the three years prior to preceding financial year will be considered. [May refer illustrative example given at Annexure-VII]

Note:- If a Bidder does not submit the aforementioned financial statements for three specified years, then Average Annual Turnover will be calculated based on financial figures of only those specified years for which requisite financial statements are submitted. Turnover will be considered '0' (Zero) for the year(s) for which requisite financial statements are not submitted.

Audited Annual Report / financial statements needs to be accompanied with UDIN number, which is mandatory from July 2019 onwards. Any Financial Report which is issued after July 2019 onwards without UDIN shall not be considered for evaluation.

D. Possession of Valid GST registration certificate: Bidders are requested to upload their **VALID GSTIN/UIN Certificate / GSTIN Number along with the Bid Document**. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal. Any misinterpretation or misinformation may attract penal action including putting the bidder on holiday / blacklisting as per rules in vogue at NRL.

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
