

NUMALIGARH REFINERY LIMITED NOTICE INVITING TENDER

Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

PRE-QUALIFICATION CRITERIA:

Subject job is a works contract and is not covered under the Public Procurement policy for MSEs. Hence, benefits to MSE and 'Start Up' bidders, including relaxation pertaining to 'average annual turnover' and 'past experience', are not applicable in this tender.

PRE-QUALIFICATION CRITERIA (PQC)

The intending bidders for above tender should meet the qualification criteria (A) & (B) given below:

- **A)** Past Experience of having successfully completed similar works* during last 10 years ending last day of month previous to the one in which the original bid due date falls, should be either of the following:
 - ➤ One similar work costing not less than Rs.113.44 Lakhs, or
 - **Two** similar works costing not less than **Rs.90.75 Lakhs each**, or
 - ➤ Three similar works costing not less than Rs.68.06 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted for inflation at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which the original bid due date falls. The values specified above are executed values, exclusive of GST / Service tax.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

Similar Works: Bidder must have experience in Interior works of Buildings in an Industrial Plant () OR in a Gas Processing-Onshore / Oil or Gas Terminals in any Indian State/Central Government Departments/PSU's/Private Sector Client.

(*) INDUSTRIAL PLANT:

"Industrial Plant" means any premises, in any part of which, a manufacturing or production process is being carried out or is ordinarily so carried on.

Note: Work carried out outside the premises of an Industrial Plant (*) OR in a Gas Processing-Onshore / Oil or Gas Terminals will **NOT** be considered as **Similar Work****.

<u>Part (B):</u> Past Experience of having successfully completed "RCC (in Framing/Roof Structures) works and any Five (05) of the following Six (06) interior works in any of their previous jobs" during last 10 years ending last day of month previous to the one in which the original bid due date falls:

1) False ceiling work,

- 2) Floor or wall tiles work,
- 3) False flooring work,
- 4) Wall or column panelling work,
- 5) Glass wall partition work,
- 6) Building electrical work.

Note for Part (B):

- a) The requirement of having experience in any Five (05) of the above Six (06) interior works may be fulfilled in a single order or in parts in multiple orders pertaining to Interior works of Buildings **irrespective of the Work order/Executed values**.
- b) Work experiences submitted for **Part** (**B**) evaluation may not be a **Similar work**** of **Part** (**A**).
- c) Relevant work order/LOA copies, BOQs and corresponding completion certificates are to be enclosed with the offer.
- d) Completion certificates should consist Name of Work, Work Order/LOA number & date, Actual completion date.
- e) Value of Work experience submitted for Part (B) evaluation need NOT qualify Part (A).

In case bidder submits experience of **Similar work**** from any private company, then as authentication of doing such jobs, bidder shall submit Income Tax TDS Certificate from the client / proof of TDS, etc.

C) AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs.68.06 Lakhs

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers "or" certification of annual turnovers for the last three financial years from a registered chartered accountant firm. Last three financial years mentioned above refers to immediate three preceding financial years wherever the last bid submission date is after 31st December. In case of tenders having last bid submission date up to 31st December and audited / CA certified turnover documents of the preceding financial year is not available, the audited / CA certified turnover documents of the three years prior to preceding financial year will be considered. [May refer illustrative example given at Annexure-VII]

Note:- The average annual turnover is calculated by adding the turnovers of 03 the specified years, divided by 03. If a Bidder does not submit the aforementioned financial statements for three specified years, then Average Annual Turnover will be calculated based on financial figures of only those specified years for which requisite financial statements are submitted. Turnover will be considered '0' (Zero) for the year(s) for which requisite financial statements are not submitted.

Audited Annual Report / financial statements needs to be accompanied with UDIN number, which is mandatory from July 2019 onwards. Any Financial Report which is issued after July 2019 onwards without UDIN shall not be considered for evaluation.

D) <u>Possession of Valid GST registration certificate</u>: Bidders are requested to upload their <u>VALID GSTIN/UIN Certificate</u> / GSTIN Number along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal. Any misinterpretation or misinformation may attract penal action including putting the bidder on holiday / blacklisting as per rules in vogue at NRL.

INSTRUCTIONS:

- 1) Tender documents should be downloaded from Central Public Procurement Portal http://eprocure.gov.in/eprocure/app. Aspiring Bidders/ Suppliers who have not enrolled/registered in e-procurement should enroll/register before participating, through the website http://eprocure.gov.in/eprocure/app. Bidders are advised to go through instructions provided as 'Instructions for online Bid Submission' provided in the next page.
- 2) Bidders can access tender documents from the website, fill them with all relevant information and submit the completed tender document into electronic tender on the website http://eprocure.gov.in/eprocure/app.
- 3) Tenders and supporting documents should be uploaded through e-procurement portal only. Hard copy of the tender documents will not be accepted.

Both Technical bid and Financial bid are to be submitted concurrently, duly digitally signed in the web site http://eprocure.gov.in/eprocure/app.

Online Bids are received only on CPPP Portal website http://eprocure/app on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
