#### PRE-OUALIFICATION CRITERIA:-

As the job nature involves human safety and integrity of erected structures, it requires experienced agencies. Therefore, it is proposed not to consider relaxation for MSE & Start-up bidder considering public safety, critical safety operation and equipment safety etc. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender.

**Past Experience** of having **successfully completed** similar works\* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:

- > One similar work costing not less than Rs.54.06 Lakhs, or
- ➤ Two similar works costing not less than Rs.43.25 Lakhs each, or
- ➤ Three similar works costing not less than Rs.32.44 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

\*Similar Works: Bidder must have experience of executing purely Scaffolding jobs OR Civil / Mechanical nature of jobs involving scaffolding in Hydrocarbon Refinery / Petro-Chemical / Fertilizer industries under PSU during last ten years where scaffolding scope to be mentioned in the Work Order and it is not necessarily a separate line item. While evaluating bid, total Work Order value will be considered.
