2. EVALUATION OF TENDER:

- Evaluation will be done on “**OVERALL LOWEST OFFER BASIS**” as per BOQ and items are **NOT SPLITABLE**. As such, bidder has to quote for all items including CAMC as per BOQ otherwise offer shall not be considered for evaluation. However, GST against CAMC shall not be considered at the time of evaluation which will start after expiry of warranty period of 05 years. The tax amount shall be paid at the prevailing rate at that time.

3. PRE-QUALIFICATION CRITERIA:

- ❖ Experiences of executing similar work i.e., Supply, Installation & Commissioning of CT scan Machine for any Govt. / Semi-Govt. dept. / PSU / Private organization of repute.
- a) Bidder should be Original Equipment Manufacturer (OEM) of the proposed CT scan Machine or Bidder should be authorized channel partner/ authorized dealer/ Indian Representative being authorized by OEM. In case of authorized channel partner/ authorized dealer/ Indian Representative, valid documentary evidence shall be furnished along with offer.
- b) Bidder should have their sales & services set-up at Kolkata/Guwahati/North East for last 3 (three) years and should be competent enough to take care for after sale services. (Authentic document must be submitted along with the tender)
- c) Bidder should be able to furnish satisfactory performance certificate from their client establishing that their installed CT scan machine is working for minimum 3- 5 years. The same may be verified directly with the client by NRL/VKNRLH.
- d) The required item must be USFDA or European CE approved (authentic documents must be submitted along with the offer).
- e) AERB Approval Certificate
- ❖ **Mandatory documents to be submitted in support of the PQC:-**
 - Documents in support of ‘a, b, c, d, & e of the PQC.
 - Copy of Work Order of having supplied similar equipment / system to any Govt. / Semi-Govt. dept. / PSU / Private organization of repute in the last 10 years to be reckoned from the bid due date.
 - Undertaking by the bidder to provide Calibration certificate along with processes at the time of delivery of the equipment.

Note:

- Both Manufacturer and their Authorized dealer cannot bid simultaneously in the same tender. In case offers are submitted by manufacturers (OEM/ Principals) directly, the offers of dealers shall be rejected for those quoted items without any further communication.
- The Model offered should be the latest High end model under current production. Refurbished - Gold Seal Units will not be accepted.
- Bidder has to upload the catalogue of offered model to verify the specifications along with the technical bid.
