PRE-QUALIFICATION CRITERIA:-

The subject job falls under the category of public safety, health, critical security of operation and equipments. Hence, there will be NO relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

- A) Past Experience of having successfully completed similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:
 - ➤ One similar work costing not less than Rs.27.75 Lakhs
 - ➤ Two similar works costing not less than Rs.22.20 Lakhs each and
 - ➤ Three similar works costing not less than Rs.16.65 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

*Similar Works: Bidder should have experience in Instrumentation/Electrical job (Maintenance or Maintenance Assistance or Erection & Installation of field instruments or electrical works, cable laying, fabrication of any structural frame/cable duct etc) in any Hydrocarbon Refinery in India.

B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs.16.65 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers and certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate

The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
