Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work: This is a price display tender

Name of Work:	Annual Rate Contract for Miscellaneous Civil Jobs at NRL Site. (Gr A & B)
Tender No. & Date:	OC19000322/ND dated 21.04.2022
Due Date of Submission:	Before 11.00 AM of 05.05.2022
Technical Bid opening date & time:	After 11.00 AM of 06.05.2022
Earnest Money Deposit:	Rs.1,00,000/-. The EMD must be submitted online on the portal of HDFC bank (instructions at Annexure-XVII below) and its receipt must be uploaded along with offer. If the EMD is not received along with the offer, offer shall not be considered for opening. However, MSE bidders are exempted from submission of EMD. MSE bidders are required to upload UAM(as explained in Annexure-X) instead of the EMD deposit receipt.
Contract Period:	24 months from the date of handing over of site.

PRE-QUALIFICATION CRITERIA

- A) Past Experience of having successfully completed similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:
- One similar work costing not less than Rs 124.55 Lakhs
 - Two similar works costing not less than Rs.99.64 Lakhs each and
 - Three similar works costing not less than Rs.74.73 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month preceding the last bid submission date.

*Similar Works: The bidders should have experience in executing "Project / Maintenance nature of Civil Works in Hydrocarbon Refinery/Petrochemical/Fertilizer Industry". (contract involving solely or in combination amongst any of the following category of works shall not be considered: Earthwork, site grading, horticulture , Jungle cutting ,drain cleaning, material supply , machinery operation ,painting ,insulation, refractory, waterproofing, fireproofing jobs.

- B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs.74.73 Lakhs
Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.
- C) Possession of Valid GST registration certificate: Bidders are requested to upload their VALID GSTIN/UIN Certificate along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.

Aspiring Bidders/ Suppliers who have not enrolled/registered in e-procurement should enroll/register before participating, through the website <http://eprocure.gov.in/eprocure/app> . Bidders are advised to go through instructions provided as 'Instructions for online Bid Submission' provided in the next page.
- 2) Bidders can access tender documents from the website, fill them with all relevant information and submit the completed tender document into electronic tender on the website <http://eprocure.gov.in/eprocure/app> .
- 3) Tenders and supporting documents should be uploaded through e-procurement portal only. Hard copy of the tender documents will not be accepted.

Both Technical bid and Financial bid are to be submitted concurrently, duly digitally signed in the web site <http://eprocure.gov.in/eprocure/app>.

Online Bids are received only on CPPP Portal website <http://eprocure.gov.in/eprocure/app> on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
