Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Erection of Pre-Engineered Steel Building and other Associated Civil Works for Wax Pastillation Project

Contract Period:	08 Months from the date of site handover

Subject job is a works contract and is not covered under the Public Procurement policy for MSEs.

PRE-QUALIFICATION CRITERIA

A) Past Experience of having **successfully completed** similar works* during last 10 years (as on the last date of the month preceding the last bid submission date) should be either of the following:

- **One** similar work costing not less than = **Rs.105.17 Lakhs**
- **Two** similar works costing not less than = **Rs.84.14 Lakhs each** and
- **Three** similar works costing not less than=**Rs.63.10 Lakhs each**.

***Similar Works:** The bidder must be experienced in successfully completing one time Civil & Structural work of project nature which should include structural steel erection job (excluding reinforcing steel) of any one of the following quantum. a) If one similar work order is furnished it must include minimum 50 Metric ton steel erection work. b) If two similar work orders are furnished it must include minimum 40 Metric ton steel erection work in each work order. c) If three similar work orders are furnished it must include minimum 30 Metric ton steel erection work in each work order. The bidder has to submit documentary evidence along with their technical bid in the form of work order clearly mentioning the quantity of steel erection work in that order, job completion certificate and shall furnish any further documents if sought for.

Note: *Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month preceding the month in which bids are invited.*

B) AVERAGE ANNUAL TURNOVER : During the last 3 financial years, shall be at least **Rs.63.10 Lakhs**.

C) Possession of Valid GST registration certificate

The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
