- **A) Past Experience** of having **successfully completed** similar works\* during last 10 years (as on the last date of the month preceding the last bid submission date) should be either of the following:
- ➤ One similar work costing not less than = Rs.4.43 Lakhs
- **Two** similar works costing not less than = **Rs.3.55** Lakhs each and
- ➤ Three similar works costing not less than=Rs.2.66 Lakhs each.

\*Similar Works: Bidder should have experience in unloading, loading and disposal of filter media in a PSU.

Note: Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

- B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs.2.66 Lakhs.
