Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Operation & Maintenance of Electrical System at NRL Township, Royal Aawas and any other location under T&E department as per instruction of EIC.

Due Date of Submission:	Before 11.00 AM of 08.05.2023
Earnest Money Deposit:	Rs.2,65,765 (Rupees Two Lakhs Sixty Five Thousand Seven Hundred Sixty Five only)
Contract Period:	One year from the date of site handover with a provision for extension for another one year with same rates, terms and condition depending on the performance of the Contractor

PRE-QUALIFICATION CRITERIA:-

The subject job being 'Works Contract', therefore, the relaxation pertaining to Prior turnover, prior experience and price benefit shall not be applicable for MSE and Start up bidders for this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

A. Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:

- **One** similar work costing not less than **Rs.66.44 Lakhs**, or
- **Two** similar works costing not less than **Rs.53.15 Lakhs each**, or
- **Three** similar works costing not less than **Rs.39.86 Lakhs each**.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be inflation adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:** 1. The Contractor must have a valid Electrical contractor license up to minimum 415V grade.

2. The contractor shall have minimum 2 years' experience in Electrical operation and maintenance work(s) in any Central Govt.org/State govt. org/Govt. PSU or any other government organization.

B) AVERAGE ANNUAL TURNOVER : During the last 3 financial years, shall be at least Rs.39.86 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
