1. EVALUATION & ORDER AWARD:

- ❖ Evaluation will be done on “ITEM WISE LOWEST OFFER BASIS” and the items are SPLITABLE.

2. PRE-QUALIFICATION CRITERIA:

- i) The bidder shall be OEM or OEM's authorized representative of the offered item. If the bidder is not OEM, valid authorization certificate from the OEM of the offered item shall be submitted along with the offer (This PQC is applicable only for the major items i.e. I-CABL-FO06C-02(OFC cable; Armored Single Mode(9.2/125µm)),I-OFC-ACC-12(10/100TX to SM SC Typ FO Media Converter),I-OFC-ACC-13(16 port Gigabit Smart switch), I-OFC-ACC-14(1000 Base-LX Mini-GBIC SM Transceiver), I-CABL-FO12C-01(12 Core SM Armored OFC cable (9.2/125µm)), I-OFC-ACC-23(High reliability Cat6 Ethernet/LAN cable) and I-OFC-ACC-24(4 port Gigabit Smart switch).
- ii) The bidder should supply compatible items/same OEM items for I-OFC-ACC-13 (16 port Gigabit Smart switch) & I-OFC-ACC-14(1000 Base-LX Mini-GBIC SM Transceiver).

2. TECHNICAL CRITERIA:

Bidder shall submit following documents as minimum for technical evaluation of their offer. Non submission or partial submission of following documents may lead to rejection of their offer:

- a) Copies of Valid documentary evidence fulfilling tender pre-qualification criteria (Technical).
- b) Technical Specifications/data sheet of the offered items mentioning exact model no & part no. of each offered item.

SPECIAL NOTE TO THE BIDDERS:

- As per CVC Circular no. 03/01/12 dated 13/01/2012 Para 3 a) both Manufacturer and their Authorized dealer cannot bid simultaneously in the same tender. If both of them participated in the same tender, then both the offers shall be rejected without any further communication.
- The requirement of Prior Turnover & Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.
- **Price preference for MSE Bidder:** The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader. For availing MSE benefit UAM based MSE certificate has to be necessarily uploaded during submission of offer. Further, *d*declaration of Udyog Adhaar Memorandum (UAM) numbers by the bidders on CPPP (i.e. e-Tenders submitted through www.eprocure.gov.in portal) needs to be ensured during bid submission.

- (a) BoQ/Priced Bid “in "XLS" format as per instructions provided.

5. GENERAL:

- i) Consortium/Joint venture bids shall not be accepted.

- ii) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- iii) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- iv) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
