BRIEF SCOPE OF WORK: As detailed in Tender Document, Special Terms & Conditions & BOQ.

BID QUALIFICATION CRITERIA:

1. Technical PQC:

- The participating bidder must have sufficient previous experience of successful execution of similar work i.e. "Design, detailed system engineering, supply & commissioning of offered make Fire alarm system" in India. Bidder shall furnish the following in documentary evidence:
 - a) At least one purchase Order Copy of similar work executed in past 5 years reckoned from the date of publication of this tender.
 - b) Completion certificate issued by end user. Alternatively MOM copy jointly signed by the bidder and the client after successful commissioning / handover would also be considered for evaluation.
- Bidder shall furnish written declaration of the offered make Fire Alarm System on availability of spares part support for next 10 years.
- Average annual financial turnover during the last three years should be positive. Bidder shall provide copies of audited account statement of last 3 financial years.

2. Commercial PQC:

Past Experience of having successfully completed similar works* during last 10 years ending last month should be either of the following:-

- One similar work costing not less than Rs.13.77# Lakh or
 - Two similar works costing not less than Rs.11.01# Lakh each or
 - Three similar completed works costing Rs.8.26# Lakh each
- *Similar works: Experience in Design, detailed system engineering, supply & commissioning of offered make Fire alarm system" in India
3. Average Annual Turnover during last 3 years, ending 31st March of previous Financial Year: At least **Rs. 8.26 lacs**. The bidder must submit copy(ies) financial documents – Trading and P/L account(s) certified by Chartered Accountant along with the un-priced bid in support of the above criteria.

4. Bidder should have following valid documents on the date of Closing of tender and copy of the same needs to be submitted along with the technical Bid:
- Provident Fund Registration Number.
 - ESI registration number.
 - Income Tax PAN Number.
 - GST Registration Number.
5. Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. **Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document.** It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

Non fulfillment of all the above mention Technical & Commercial Qualifying criteria will lead to disqualification of bidder.
