Online Bid and EMD Submission:	Before 11:00 AM of 18.04.2022
Earnest Money Deposit:	₹ 16,000.00 (Rupees Sixteen Thousand Only) <i>The EMD must be submitted online on the portal of HDFC bank (instructions at Annexure-XVII below) and its receipt must be uploaded along with offer. If the EMD is not received along with the offer, offer shall not be considered for opening. However, MSE bidders are exempted from submission of EMD. MSE bidders are required to upload UAM or EM Part-II (as explained in Annexure-X) instead of the EMD deposit receipt.</i>
Contract Period:	02 (Two) years from the date of site handover.

PRE-QUALIFICATION CRITERIA:-

A) Past Experience of having **successfully completed** similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:

- **One** similar work costing not less than **₹ 15.69 Lakhs**
- **Two** similar works costing not less than **₹ 12.55 Lakhs each** and
- **Three** similar works costing not less than **₹ 9.41 Lakhs each**.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

***Similar Works:** The bidder should have experience in designing , preparation and supply of signboard on Acrylic sheet/ Aluminium sheet/ MS sheet/ FRP sheet with pasting of retro-reflective/ radium/ vinyl sheet with printing of text , drawing etc. / cutting and pasting of retro-reflective/ radium/vinyl letters on retro-reflective/ radium/vinyl sheet and installation of the signboard in any area.

B) AVERAGE ANNUAL TURNOVER : During the last 3 financial years, shall be at least **₹ 9.41 Lakhs**.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate: Bidders are requested to upload their **VALID GSTIN/UIN Certificate** along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.

Online Bids are received only on CPPP Portal website <http://eprocure.gov.in/eprocure/app> on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
