Name of Work:	Supply, Installation, Testing & Commissioning of Area Lighting and Landscape Lighting in various location(s) under T&E [Township & Estate] Department as per the Technical Specifications / Item description referred in Annexure-1 (SOR).

Earnest Money Deposit:	Nil. Bidders are required to submit "Declaration for bid security / Earnest Money Deposit (EMD)" enclosed as Annexure-XVI.
Contract Period:	12 Months from the date of site handover

The subject job is a works contract and is not covered under the Public Procurement policy for MSEs.

PRE-QUALIFICATION CRITERIA

- A. **The bidder must have a valid Electrical contractor license up to 11KV and above** (the license should be sole name of the bidder only). Copy of the License should be submitted with offer.
- B. **The bidder should have experience in supply & Erection testing commissioning / Maintenance of any electrical Work in any central Govt./ State Govt./Govt. PSU during last 10 years as on bid closing date of this tender.** Work Order copy and completion certificate shall be enclosed with the offer. The completion certificate must have completion date and value of work executed.

Note-1: Vendor is liable to rejection if completion certificate (with completion value and completion date) is not furnished with tender document.

Note-2: For accepting experience as sub-contractor(s) or contractors under Private Organizations, in addition to the requisite certificates (letter of award and job completion certificate etc.) TDS certificate issued by principal contractor /private organization shall form the basis for considering experience and value of work executed.

- C. **Past Experience** of having **successfully completed** similar works* during last 10 years (as on bid closing date of this tender) should be either of the following:
- **One** similar work costing not less than = **Rs. 93.87 Lakhs**
 - **Two** similar works costing not less than = **Rs. 75.10 Lakhs each** and
 - **Three** similar works costing not less than=**Rs. 56.32 Lakhs each.**

***Similar Works: The bidder should have experience in supply & erection testing commissioning / maintenance of any electrical Work in any central Govt./ State Govt./Govt. PSU during last 10 years as on bid closing date of this tender.**

Note: Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

- D. **AVERAGE ANNUAL TURNOVER:** During the last 3 financial years, shall be at least Rs. 56.32 Lakhs.
- E. **Possession of Valid GST registration certificate:** Bidders are requested to upload their **VALID GSTIN/UIN Certificate along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.**
- Any misinterpretation or misinformation may attract penal action including putting the bidder on holiday / blacklisting as per rules in vogue at NRL.

F. ADDITIONAL REQUIREMENTS:

- a. Possession of Income Tax PAN No.; PF code, ESI, GST registration certificate, etc.
- b. 'Integrity Pact' duly signed and stamped on each page without which offers will not be considered.
