- 2.3 This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.
- 2.4 Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.
- 2.5 Subsequent Corrigendum/ Addendum (if any) shall be published in our e-tendering portal <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>
- Any modification of the Bidding Document, which may become necessary as a result of the bidder's query/ pre-bid discussion, shall be published in e-tendering portal (<a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>) through the issue of an Addendum/ Amendment/ Corrigendum/Clarifications.
- 2.7 **EARNEST MONEY DEPOSIT:** Not Applicable.
- 2.8 **HOLIDAY LISTING:** Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.

#### 2.9 PRE-QUALIFICATION CRITERIA (PQC):

The bidders who intend to participate in the tendering process shall meet all the following minimum requirements and only such bidders shall be pre-qualified technically for further evaluation:

- 1) The bidder shall be an approved certificate holder of ASME Section VIII, Division 1: "UV Stamp for Pressure Relief Devices". The UV stamp certificate issued by ASME and valid as on the bid opening date shall have to be furnished by the bidder.
- 2) The vendor must be a manufacturer of IBR Pressure Relief Valves for the IBR valves and must submit IBR registration certificate issued by the Director of Boiler for manufacturing of PSV and TSV as per IBR ACT 1950. The said certificate must be valid as on the bid opening date.
- 3) The vendor shall have to submit past Purchase Order copies as a proof of supplying IBR PSV for IBR valves in the tender as well as non-IBR PSV as per the service requirement to any Public or Government sector Industry operating in the hydrocarbon sector. Data sheets of the cited reference PSVs shall have to be furnished along with the Tender documents.
- 4) The Vendor shall have to submit Satisfactory Performance Certificate issued by Competent Authority to testify the performance of the Valves cited as reference as per Sl. No.3 of Pre-Qualification Criteria.

#### Note:

- i. NRL adopts a practice to verify documents submitted by L1 (successful) bidder in support of bidder's credential against PQC. Authentication may be verified with the issuing authorities, by way of direct communication to NRL over official e-mail IDs / Original letter of authentication by post. Bidders may also follow up with the issuing authority for eliciting early response. If documents remain unauthenticated till given time line, NRL reserves the right to reject the bid. Proper address for communication, including e-mail ID of the issuing authority should be provided along the tender document.
- ii. Offer will be considered only when NRL is satisfied with experience and capability of the tenderer to take up this work.
- iii. Failure to submit the relevant documents as sought along with the tender documents will disqualify the vendor without any further communication.
- iv. PQC Sl. No. 3 & 4 are however relaxed for M/s Anderson Greenwood Crossby Sanmar Limited; M/s Bliss Anand & M/s IIL as PSVs of these makes have been in service in NRL since long and performance established over the years.

#### 2.9.1. PQC RELAXATION FOR MSME/START-UPs:

Pre-Qualifying Criteria mentioned in the tender is mandatory for all participating bidders including MSEs and Start Ups as The PSVs are installed in critical Plant Operations and concerns Plant & Human safety.

<u>Supporting documents for Startup:</u> Bidder who intends to participate as 'Start-up' company should enclose the Certificate of Recognition issued by Department of Industrial Policy and Promotion, Ministry of Commerce & Industry, Govt. of India.

**Note:** Above supporting documents are required to be uploaded by bidder along with un-priced technocommercial bid only. It is the responsibility of the bidder to upload the above supporting documents along with their un-priced techno-commercial bid for availing relaxation on Prior Turnover and Prior Experience (if applicable in this tender). In case of non-receipt of above documents along with bidder's un-priced bid, no further communication in this regard will be carried out to ascertain bidder's qualification as 'MSE bidder/

Startup' and relaxation on Prior Turnover and Prior Experience (if applicable in this tender) will not be passed on to bidder.
