- 1. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 2. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

4. Buyer Added Bid Specific ATC

Pre-Qualification Criteria: (Must furnish to be eligible for evaluation)

Bids invited from reputed TMBV valve manufacturers with a proven track record who have the following cr edentials:

- 1. The bidders shall have manufactured and supplied at least 01 no's of Trunnion Mounted Ball valve of si ze 8 Inch or above to any Oil & Gas industry/ Petrochemical industry within last 10 years to be counted from the bid due date. Bidder shall submit copies of relevant Purchase / Work Order containing the item description, ordered quantity along with Invoices/inspection release notes/completion certificate or any other such documents in proof of meeting above requirements.
- 2. Bidders shall have facility in their own name for manufacturing; testing and delivering the valves of NRL required specification to NRL SMT site.
- 3. Trunnion Mounted Ball Valve supplied as per above clauses i.e. 1 & 2 shall have completed not less than 12 months of successful operation. Bidder shall submit confirmation from their clients regarding satisfactory performance/usages of the same. Bidders shall also submit list/references of clients with conta ct details where the offered system is supplied & working satisfactorily.
- 4. Bidders shall have valid ISO certification for manufacturing facility and quality management. Bidders shall submit copies of valid ISO certificates in support of the same.

- 5. Vendor shall submit all the drawings and technical specifications of their product along with technical bi
- 6. Bidder to Note: This procurement shall be made in accordance with technical tender document (NRL/ SM T/ DOC/TT/ROSOV-TMBV, Rev-01) enclosed with the enquiry. Bidder to enclose this document along with the eir offer duly stamped and signed as a token acceptance of the same, otherwise the bid is liable for rejection.

Payment Term:

- 1. 90 % payment along with full taxes and duties after receipt and acceptance of material at SMT NRL Site.
- 2. Balance 10% after successful Installation & commissioning of the equipment at site as well as after performance testing of the equipment in all respect and on submission of performance bank guarantee for 10% of total order value, valid till full guarantee period plus three months.
- 3. Notes on payment terms:
 - 1. i. Third Party Inspection charges shall be released by NRL separately against submission of TPIA cer tificate and invoice thereof, upon endorsement by EIC. EIC reserves the right to accept or reject pho tocopies of certificate submitted in lieu of original.
 - 2. ii. All payments shall be released within specified days of receipt of invoice (in original) and all requi site documents, complete in all respects.
 - 3. iii. Chief Manager (SMT) of NRL or his sub-delegated authority shall be the Engineer In Charge (EIC) f or the job.

5. Scope of Supply

Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
