Numaligarh Refinery Limited (NRL) invites e-bids from competent and experienced Indian supplier for the following under two bid system (Part-I: Techno-commercial part and Part-II: Price Part) with sound technical and financial capabilities fulfilling the Pre- Qualification Criteria (PQC) of the tender document.

The E-Bid should be prepared in Two Parts as per the following details.

- ii) PART - II : Price Bid

Note:

- i) Only online offer shall be considered against the subject enquiry. For details please go to our e-tendering portal <http://eprocure.gov.in/eprocure/app>
- ii) This Tender is being conducted in e-tendering mode and the Bid documents can be downloaded for ONLINE bidding by the bidders, who has the Digital Signature Certificates.

- iv) **Bids received by way of Post, Courier, Fax, Telex or Telegram or email or in open condition shall not be considered.**
- v) Corrigendum, Addendum (if any) will be published in e-tendering portal (<http://eprocure.gov.in/eprocure/app>) only.

3. **EARNEST MONEY DEPOSIT:** Not applicable.

4. **Bidders who are on holiday list by NRL or any other Oil sector PSU will not be considered. Accordingly, the bidder shall submit a self-declaration as per format enclosed with Tender Document. It may be noted that if this declaration is found to be false, NRL shall have the right to reject bidder's offer, and if the bid has resulted in a contract, the contract is liable to be terminated.**

5. PRE-QUALIFICATION CRITERIA (PQC):

- 5.1 The bidder must be a ISO-9001:2008 certified company for quality management system. Valid ISO certificate to be submitted along with offer.
- 5.2 To get qualified for IS: 2062 grade Angles and Channels the bidder must furnish a copy(s) of purchase order(s)/Work order(s) of IS: 2062 grade Plate/Angle/Channel from any Refinery/PSU company/Petrochemicals/Govt. organization in last 05 (five) years to be reckoned from final bid due date. Similarly for Carbon Steel & Stainless Steel plates the bidder must furnish copy of purchase order(s)/Work order(s) of ASTM 516 Gr 60 or ASTM 516 Gr. 70(for CS plates) & Stainless Steel 304/310/316/321/347/410 plate(for SS plates) from any Refinery/PSU/Petrochemicals/Govt. organization in last 05 (five) years to be reckoned from final bid due date.
- 5.3 The bidder shall not be under Holiday listing/ Blacklisting period by any Govt. body/ PSU during the tender period. An undertaking to this effect to be submitted as per format enclosed.

Note: *The intending bidders shall have to furnish proof of their pre-qualification along with the Techno-commercial bid. Copies submitted in support of credentials shall be self-attested. Pre-qualification criteria will be checked at the time of techno-commercial evaluation of the offer. Bidders are to know that no further communication may be done to ascertain their prequalification. The offers with incomplete /irrelevant documents / anomalies may be straightway rejected without any communication.*

Hence, bidders are advised to take utmost care while submitting their prequalification documents at the time of offer.

- b) Technical Specifications for Steel Plates, Angles and Channels (Technical Doc. No. NRL/PS/PL/20190223 REV.0) duly sealed & signed; as a token of acceptance.
- c) Agreed Terms & Conditions (ATC) duly filled, signed & stamped. The commercial terms & conditions should not be repeated in the offer.
- d) Bidder's Self-Declaration of black listing/ holiday listing as per Performa enclosed - duly signed & sealed.
- e) MSE bidder may submit EM (Part-II)/ UAM wherein bidder is registered as 'Micro/ Small Enterprise' [refer Annexure-X enclosed]
- f) In case of availing benefits under Purchase Preference Policy (Linked with Local Content) (PP-LC Policy), bidder to submit documents as per Special Conditions of Contract (SCC) and 'Table 1: Calculation of Local Content – Supply Contracts (Goods)' (i.e. Page 5 of 7 of SCC) to be stated as **'QUOTED IN PRICED BID'**
- g) Vendor Details as per Format enclosed.

7. DOCUMENTS TO BE SUBMITTED AS A PART OF PART – II: PRICED E-BID:

- BoQ/Priced Bid "in "XLS" format as per instructions provided.
- In case of availing benefits under Purchase Preference Policy (Linked with Local Content) (PP-LC Policy) (as explained per Special Conditions of Contract enclosed), bidder shall provide break up of "Local component" and "Imported Component" along with their price bid (in PDF) as per format in 'Table 1: Calculation Of Local Content – Supply Contracts (Goods)'; refer page 5 of 7 of Special Conditions of Contract (SCC).

8. **EVALUATION OF THE TENDER:** Tender shall be evaluated on 'Itemwise Lowest Offer Basis'.

9. **TENDERS FROM MICRO AND SMALL ENTERPRISES (MSEs): Refer Annexure-X**

10. **GENERAL:**

- i) **Consortium/Joint venture bids shall not be accepted.**
- ii) Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- iii) In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- iv) NRL reserves the right to defer the date/time of opening of the offer; to make changes in the terms & conditions of tender document and to reject any or all bids without assigning any reason thereof.
