#### 1. EVALUATION & ORDER AWARD:

- A) Offer shall be evaluated on "GROUP WISE OVERALL LOWEST OFFER BASIS" (L1) and items are NOT SPLITABLE for each group as follows:
- ❖ Group A: Offer shall be evaluated for first 46 Nos. of items (From Item Sl. No. 10 to 460 i.e. material code I-CONSUMABLE-0004 to I-SWACHTA-KIT-1-00) on overall L1 basis.
- ❖ Group B: Offer shall be evaluated for next 27 Nos. of items (From Item Sl. No. 470 to 730 i.e. material code I-CABLETIE-200-1 to I-CABLETIE-100-1) on overall L1 basis.
- ❖ Group C: Offer shall be evaluated for last 2 Nos. of items (From Item Sl. No. 740 to 750 i.e. material code I-FERL-PRT-00 to I-FERL-PRT-01) on overall L1 basis.

As such bidder has to quote for all items as per the Group Wise BOQ otherwise offer shall not be considered for evaluation.

**B**) Bidders has the option of quoting for one group or for all groups based on their qualifications.

#### **2.** PRE-QUALIFICATION CRITERIA:

1. The bidder must have prior experience in the supply of consumable/tools/ electrical goods/ fittings & fixtures/ Hardware items to any oil Refinery in India during the last 10 years. Accordingly bidder shall submit relevant PO/WO copies along with the offer.

#### **SPECIAL NOTE TO THE BIDDERS:**

- ➤ As per CVC Circular no. 03/01/12 dated 13/01/2012 Para 3 a) both Manufacturer and their Authorized dealer cannot bid simultaneously in the same tender. If both of them participated in the same tender, then both the offers shall be rejected without any further communication.
- > The requirement of Prior Turnover & Prior Experience (if any, indicated in the tender document) will be relaxed if the bidder is Micro and Small Enterprise (MSE) or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.
- ➤ Price preference for MSE Bidder: The price benefit/preference as per MSE policy will be extended only to the original manufacturer and not to trader. For availing MSE benefit UAM based MSE certificate has to be necessarily uploaded during submission of offer. Further, declaration of Udyog Adhaar Memorandum (UAM) numbers by the bidders on CPPP (i.e. e-Tenders submitted through <a href="www.eprocure.gov.in">www.eprocure.gov.in</a> portal) needs to ensured during bid submission.
