IMPORTANT NOTE:

- 1) Tender documents may be downloaded from Central Public Procurement Portal <https://eprocure.gov.in/eprocure/app>. Aspiring Bidders/ Suppliers who have not enrolled/registered in e-procurement should enrol/register before participating through the website <https://eprocure.gov.in/eprocure/app>. The portal enrollment is free of cost. Bidders are advised to go through instructions provided at **Annexure-A regarding 'Instructions for online Bid Submission'**.

Brief Description of the Job: Structural Replacement of Elevated Flare supporting Structure during Shutdown'2016.

Contractual Period: All fabrication jobs shall be completed before starting of shutdown at designated place as per the instruction of EIC. Only dismantling and erection of structural members shall be carried out during shutdown. The time period for fabrication is 15 days (prior to Shutdown) & for erection and dismantling is 10 days (during Shutdown), which may further vary as per operational requirement during Shutdown.

QUALIFICATION REQUIREMENT:

The intending bidders for above tender should meet the qualifications as given below:

1. **Past Experience** of having successfully completed **similar works*** during last 10 years ending last month should be either of the following:-

- Three completed similar work costing not less than **Rs 2.73 lakhs** each or
- Two completed similar works costing not less than **Rs. 3.64 lakhs** each, or
- One completed similar works costing not less than **Rs. 4.54 Lakhs**.

Similar work: Bidder should have experience in “**Fabrication and erection of structural works during Shut Down in Refinery / Fertilizer /chemical Industry**”.

(Work order and completion certificate should be furnished in support of requirements mentioned above)

The value of past experience shall be adjusted (enhanced) at a simple rate of 07% for every completed year (ending last day of the month, preceding the month in which bids are invited).

2. Participating contractor has to furnish declaration that they own following equipment and system and the same shall be deployed at site at the start of the work as per requirement as directed by E-I-C.

i) Machines/equipments/tools & tackles:

1. Welding Machine - 04 nos. (minimum)
2. Gas cutting set - 03 nos. (minimum)
3. Grinding Machine - 02 nos. (minimum)
4. Safety net (7m x 7m) - 02 nos. or more.
5. Safety belt and other harness for working at height : Minimum 20 nos. or more to cater the need of each workers working at height.
6. Rope pulley - 03 nos. [pulley of 1MT capacity 03 nos. and 3 nos. of rope of 200 m length in good condition]

ii) Manpower:

1. Welder - 06 nos. (minimum)
2. Gas cutter - 04 nos. (minimum)
3. Rigger - 08 nos. (minimum)
4. Fitter - 02 nos. (minimum)
5. Helper - 20 nos. (minimum)

3. **Average Annual Turnover** during the last 3 years, ending 31st March of the previous financial year, shall be at least **Rs. 2.73 lakhs**. The bidder's financial capability shall be decided based on the average annual turnover and concurrent commitments.
4. **Possession of Income Tax PAN No.; Service Tax Registration no.**
