IMPORTANT NOTE:

- 1) Tender documents may be downloaded from Central Public Procurement Portal <https://eprocure.gov.in/eprocure/app>. Aspiring Bidders/ Suppliers who have not enrolled/registered in e-procurement should enrol/register before participating through the website <https://eprocure.gov.in/eprocure/app>. Brief Description of the Job: CIVIL STRUCTURAL & PAINTING JOBS FOR SHUTDOWN 2016.

Contractual Period: Contractual period for this job may be considered as 30 (thirty) days. Initial 10 days may be considered as preparatory job period for jobs which can be taken up before start of shutdown like fire training, gate pass, material issue ,erection of scaffolding for identified jobs (e.g scaffolding job for heater shell painting) .However all major structural/painting jobs shall required to be executed within this 10 days period to make the plant operational. For any other secondary job like housekeeping, scrap disposal etc which does not hamper the commissioning and operation of plant another 10 days of extension period may be considered as per decision of EIC.

QUALIFICATION REQUIREMENT:

The intending bidders for above tender should meet the qualifications as given below:

1. **Past Experience** of having successfully completed **similar works*** during last 10 years ending last month should be either of the following:-

- Three completed similar work costing not less than **Rs. 6.82 lakhs** each or
- Two completed similar works costing not less than **Rs. 9.09 lakhs** each, or
- One completed similar works costing not less than **Rs. 11.37 Lakhs**.

Similar work: Bidder should have experience in “**Structural Steel works during shut down / RTA**”

(Work order and completion certificate should be furnished in support of requirements mentioned above)

The value of past experience shall be adjusted (enhanced) at a simple rate of **07%** for every completed year (ending last day of the month, preceding the month in which bids are invited).

2. **Average Annual Turnover** during the last 3 years, ending 31st March of the previous financial year, shall be at least **Rs 6.82 lakhs**. The bidder's financial capability shall be decided based on the average annual turnover and concurrent commitments.
