

# NUMALIGARH REFINERY LIMITED NOTICE INVITING TENDER

Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	AMC for assistance in maintenance of Telecommunication Network System in Refinery, NRMT, Township & CISF Colony.

Contract Period:	02 (two) years from the date of handing over of site and extendable by another 1 (one) year with same terms & conditions.		

#### PRE-QUALIFICATION CRITERIA:-

The subject job falls under the category of public safety, health, critical security operation and equipment's etc. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender.

**A)** Past Experience of having successfully completed similar works\* during last 10 years ending last day of month previous to the one in which the original bid due date falls, should be either of the following:

- One similar work costing not less than Rs. 45.82 Lakhs, or
- Two similar works costing not less than Rs. 36.66 Lakhs each, or
- Three similar works costing not less than Rs. 27.49 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which the original bid due date falls.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

\*<u>Similar Works</u>: Bidder shall have experience in executing Telecommunication/Electrical maintenance/ Electrical installation and commissioning jobs in any Hydrocarbon Refinery in India.

#### **B) Additional Mandatory Technical Qualification:**

i) Bidder should have a valid electrical contractor's license for minimum 650V system issued by Competent Authority. Same shall be furnished with the bid.

# AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs. 27.49 Lakh.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers "or" certification of annual turnovers for the last three financial years from a registered chartered accountant firm. Last three financial years mentioned above refers to immediate three preceding financial years wherever the last bid submission date is after 31st December. In case of tenders having last bid submission date up to 31st December and audited / CA certified turnover documents of the preceding financial year is not available, the audited / CA certified turnover documents of the three years prior to preceding financial year will be considered. [May refer illustrative example given at Annexure-VII]

Note:- If a Bidder does not submit the aforementioned financial statements for three specified years, then Average Annual Turnover will be calculated based on financial figures of only those specified years for which requisite

financial statements are submitted. Turnover will be considered '0' (Zero) for the year(s) for which requisite financial statements are not submitted.

Audited Annual Report / financial statements needs to be accompanied with UDIN number, which is mandatory from July 2019 onwards. Any Financial Report which is issued after July 2019 onwards without UDIN shall not be considered for evaluation.

C) Possession of Valid GST registration certificate: Bidders are requested to upload their <u>VALID GSTIN/UIN Certificate</u> / GSTIN Number along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal. Any misinterpretation or misinformation may attract penal action including putting the bidder on holiday / blacklisting as per rules in vogue at NRL.
