NRL Clarified: Recommended make of Camera system (including housing/ enclosure/ ptz/ video encoder): Pelco, Honeywell, BOSCH, Axis. Same will be incorporated and detailed in the corrigendum in SSC of tender document.

• Resolution of camera to be mentioned

NRL Clarified: Camera shall be of 2megapixel@15fps (or more) with H.264/MPEG-4 or better compression technique.

Degree of protection should be IP68

NRL Clarified: Degree of protection will be same as mentioned in the tender document(SSC page 6 of 18). However, bidder can supply with higher degree of protection.

• System should have higher space(storage) for RAID 5.

NRL Clarified: As per tender specification. Permamnat storage will be at NAS and temporary continuos storage with for 72 hrs will be at server. RAID will be available both for server and NAS.

· UPS of 3kbps is required.

NRL Clarified: NRL will provide UPS power from existing facility.

NRL Clarified: Redundant NAS has to be provided by bidder. NAS specification is mentioned in tender. After 90 days, recording is to be transfered to magnetic tap as mentioned in tender.

 Detecting flames and dense vapor cloud: Is this capability required only in software or it can be in the camera or combination of camera and software.

NRL Clarified: Either one.

NRL Clarified: Scanning system will be 2:1 interface as mentioned in SSC, page 6 of 18.

- Request you to please also allow focus mode auto/semiautomatic/manual NRL Clarified: Focus mode will be Auto/focus /one shot as mentioned in SSC, page 6 of 18
- Reginal focus is also equivalent to EIS since it is help to get clear image so request you to also allow reginal focus.
 NRL Clarified: Electronic stabilization will remain as mentioned in SSC, page 6 of 18.
- Network switch specifications are not mentioned in the tender. Also please confirm us what will be port density for switches.
 NRL Clarified: Network switch recommended make will be moxa, belden, hiechmann, cisco. Same will be incorporated and detailed in the corrigendum in SSC of tender document.
- As per general specifications failover required in VMS but as per BOQ server qty is only 1 nos instead of 2 nos(page no.3, point no. 3.5 b). Please clarify.

NRL Clarified: Redundant NAS has to be provided.

 As per general specifications 72 hours recording mentioned but at which resolution, FPS, compression standard not mentioned(page no.2, point no. 3.4b). Please provide the standards for storage calculations.

NRL Clarified: As mentioned above.

- NAS specifications are not given as per industry standard. Also there is confusion regarding storage, is it a specific requirement of NAS or NVR? Please clarify whether Server+NAS or NVR is required.
 NRL Clarified: Server+NAS.
- Type of video analytics feature not mentioned. Kindly clarify. NRL Clarified: Video analytics feature will be as mentioned in the SSC, page no. 12 of 18.

 Camera Mounting Pole specs are not defined, please confirm the height & specification of Pole and suggest where to included the same for quoting.

NRL Clarified: Pole of Minimum 3m height, CS. It is included in the Exp PTZ camera with accessories(BOM, sl. No.10).

- None of the OEM have 36X optical ZOOM in HD Exproof PTZ camera, request you to kindly amend the same to 30 X as per industry standard.
 NRL Clarified: Zoom(minimum) will be Optical: 20C, Digital:10X.
 Same will be incorporated in the addendum of tender document.
- PAN/Tilt speed is not defined in the tender, request you to specify the PAN/Tilt speed so that target is not missed while camera movement. Industry Standard is 100-150 Degree per sec.

NRL Clarified: It will be as per vendor specified.

• Please confirm the switch type for control room i.e Industrial or Commercial.

NRL Clarified: Network switch(industrial type) recommended make will be SIXNET, Cisco, MOXA, Ruggedcom, Allied Telesis, Garrettcom. Same will be incorporated and detailed in the corrigendum in SSC of tender document.

 Request you to kindly consider below payment terms as per industry Standard:

Supply: 90% against the receipt of material at site.

Balance 10 % against equivalent PBG or after installation & commissioning.

Service: 100% after successful installation & Commissioning.

NRL Clarified: Though Spares are not part of priced BOQ, bidder has to mention all the spares with prices valid for a minimum period of 5 years with proper justification. To be submitted in un-priced bid. It will not be considered in bid evaluation. However, if required, price justification has to be submitted.
- As per our understanding, Fire detection is required here. However Analytics are only sued with fixed camera as Video Management Software detects the changes in the frames, as PTZ cameras are asked in this tender, request you to kindly remove this clause or if this is to be used then camera shall be used as fixed camera, Please confirm.

NRL Clarified: Software should have facility to detect flames and dense vapor cloud.

 Please confirm if Road cutting or digging is to be considered for cable laying, if yes please suggest minimum benchmark quantity for even competition at the bidding stage.
