PRE-QUALIFICATION CRITERIA

- **A) Past Experience** of having **successfully completed** similar works* during last 10 years (as on the last date of the month preceding the last bid submission date) should be either of the following:
 - ➤ One similar work costing not less than = Rs. 72.34 Lakhs
 - > Two similar works costing not less than = Rs. 57.87 Lakhs each and
 - Three similar works costing not less than = **Rs. 43.40 Lakhs each**.

*Similar Works: The bidder must have experience in maintaining the Illumination system which includes Rectification/Restoration/Replacement/Renovation/Repairing/Reliability and Requirement in Public sector Refinery/Petrochemicals/Oil & gas installations (within last 10 years)

Note: Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs. 43.40 Lakhs.

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
