- **One** similar work costing not less than = **Rs. 5.78 Lakhs**
- **Two** similar works costing not less than = **Rs. 4.62 Lakhs each** and
- **Three** similar works costing not less than = **Rs. 3.47 Lakhs each.**

***Similar Works:** Bidder shall have experience in Inspection & Certification of Pressure Vessels and Lifting Tools & Tackles by Competent Persons as per the provisions of The Factories Act, 1948 & Assam Factories Rule, 1950 in petroleum refinery, petrochemical or fertilizer industries in India. (within last 10 years)

Note: Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.
