

# NUMALIGARH REFINERY LIMITED NOTICE INVITING TENDER

Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

#### PRE-QUALIFICATION CRITERIA:-

The subject job being 'Work Contract', therefore, the relaxation pertaining to Prior turnover, prior experience and price benefit shall not be applicable for MSE and Start up bidders for this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

- **A) Past Experience** of having **successfully completed** similar works\* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:
  - ➤ One similar work costing not less than Rs.45.38 Lakhs, or
  - ➤ Two similar works costing not less than Rs.36.30 Lakhs each, or
  - ➤ Three similar works costing not less than Rs.27.23 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

\*Similar Works: The contractor should have experience in electrical maintenance/electrical renovation/electrical revamp job in Central Govt.org/State govt. org/Govt. PSU or any other government organization.

## B) AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs.27.23 Lakhs

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

#### C) Possession of Valid GST registration certificate
