PRE-QUALIFYTING CRITERIA:

- A) Past Experience of having successfully completed similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:
 - ➤ One similar work costing not less than Rs.71.49 Lakhs, or
 - **Two** similar works costing not less than **Rs.57.19 Lakhs each**, or
 - ➤ Three similar works costing not less than Rs.42.90 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

- *Similar Works: The bidder shall have experience in Electrical works up to 11KV in Public sector unit (PSU) of oil refinery/petrochemical complex/fertilizer complex in India.
- **B) ADDITIONAL MANDATORY REQUIREMENT:** Contractor should have valid electrical license of minimum 11KV voltage level. Same should be submitted during bid submission.
- C) AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs. 42.90 Lakhs #.
- D) <u>Possession of Valid GST registration certificate</u>: Bidders are requested to upload their <u>VALID GSTIN/UIN Certificate</u> / GSTIN Number along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal. Any misinterpretation or misinformation may attract penal action including putting the bidder on holiday / blacklisting as per rules in vogue at NRL.

- 2) Bidders can access tender documents from the website, fill them with all relevant information and submit the completed tender document into electronic tender on the website https://eprocure.gov.in/eprocure/app.
- 3) Tenders and supporting documents should be uploaded through e-procurement portal only. Hard copy of the tender documents will not be accepted.

Both Technical bid and Financial bid are to be submitted concurrently, duly digitally signed in the web site https://eprocure.gov.in/eprocure/app.

Online Bids are received only on CPPP Portal website https://eprocure.gov.in/eprocure/app on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
