Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Operation & Maintenance of Electrical System at CISF Complex, Dhansiri Nagar & any other location(s) under T&E Department, NRL.

Contract Period:	24 months from the date of site handover.

PRE-QUALIFICATION CRITERIA:-

The subject job being 'Work Contract', therefore, the relaxation pertaining to Prior turnover, prior experience and price benefit shall not be applicable for MSE and Start up bidders for this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

A) Past Experience of having **successfully completed** similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:

- **One** similar work costing not less than **Rs.73.28 Lakhs**
- **Two** similar works costing not less than **Rs.58.62 Lakhs each** and
- **Three** similar works costing not less than **Rs.43.97 Lakhs each.**

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. **The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date.** The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:**

- The contractor must have a valid Electrical contractor license of minimum 11KV, as on the date of publication of the tender.
- The contractor should have a minimum of 10 years' experience in electrical operation and maintenance work(s) in any Central Govt.org/State govt. org/PSU. The bidder has to submit the completion certificate along with work order copies in support of the same,(not older than 10 years).

Note: The vendor is liable to rejection if any one of the above certificates is not furnished with the tender document

B) AVERAGE ANNUAL TURNOVER : During the last 3 financial years, shall be at least Rs.43.97 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
