Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Supply, Installation, testing and Commissioning of Lightning Protection System (as per IS/IEC 62305) at NRL site, Phase-II (File ref PUR-ELECMNT-1003328)

Earnest Money Deposit:	₹ 1,00,000.00 (Rupees One Lakh Only) The EMD must be submitted online on the portal of HDFC bank (instructions at Annexure-XVII below) and its receipt must be uploaded along with offer. If the EMD is not received along with the offer, offer shall not be considered for opening. <i>However, MSE bidders are exempted from submission of EMD. MSE bidders are required to upload Udyam Registration Certificate (as explained in Annexure-X) instead of the EMD deposit receipt.</i>
Contract Period:	12 months from the date of PO.
Pre-Bid Meeting	Time & Date: At 2 PM of 18th May, 2022 Mode: Both Offline and Online Refer Tender Document for details.

PRE-QUALIFICATION CRITERIA:

Subject job is a works contract and is not covered under the Public Procurement policy for MSEs.

The intending bidders for above tender should meet all the qualification criteria given below:

- A) Past Experience** of having **successfully completed** similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:
- **One** similar work costing not less than **₹ 123.56 Lakhs**
 - **Two** similar works costing not less than **₹ 98.85 Lakhs each** and
 - **Three** similar works costing not less than **₹ 74.13 Lakhs each.**

Note: *Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.*

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:**

1. Bidder's offered items shall be manufactured as per compliance of IEC/EN 62561 (refer item specification). Manufacturing test reports (MTR) for External Lightning Protection components and SPDs from NABL/ILAC accredited laboratory to be submitted.
2. Bidder shall have the experience of successfully completed execution of both external and internal lightning protection system as per IS/IEC 62305. Bidder shall submit Purchase order copy and successful completion certificate (at least one) from any organization to meet the technical criteria. Standard IS/IEC-62305 should be clearly mentioned in the PO/Completion certificates/Tender Documents, failing which it will not be considered for evaluation.

- B) AVERAGE ANNUAL TURNOVER :** During the last 3 financial years, shall be at least **₹ 74.13 Lakhs.**

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

- C) Possession of Valid GST registration certificate:** Bidders are requested to upload their **VALID GSTIN/UIN Certificate** along with the Bid Document. NRL at its discretion may not consider the bidder's bid for further evaluation if the same is not found uploaded with the bid or not found to be valid in GST portal.

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
