#### **Bid Corrigendum**

#### GEM/2025/B/6318698-C1

Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

## **Buyer Added Bid Specific Additional Terms and Conditions**

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.
- 2. Buyer Added text based ATC clauses

BIIDERS ARE REQUESTED TO GO THROUGH THE DETAILED TENDER DOCUMENT ALONG WITH TENDER AN NEXURES/POLICIES/FORMATS/INSTRUCTIONS/PQC/TERMS & CONDITIONS ETC. AS ENCLOSED IN BUYER AD DED BID SPECIFIC ATC (UPLOADED)

Participating bidders for the tender shall meet all the qualification criteria given as below:

## **Bid qualification Criteria (BQC):**

- 1. The bidder must be a manufacturer or an authorized dealer of Steel Pipes/Tub es that meet ASTM A 106 /A 312/A 335 standards. In the case of an authorized dealer, a valid dealership certificate must be submitted along with the bid. Bidd er must furnish any one of the following documents along with the technical bid to establish its or the represented Pipe/Tube Manufacturing company's status a s a manufacturer of Steel Pipes/Tubes.
  - ISO Certificate / UDYAM Registration Certificate / Pressure Equipme nt Directive Certificate/ Factory License/ / NSIC Certificate
- 2. The bidder or the Pipe/Tube Manufacturing company they represent must have valid enlistment with EIL (Engineers India Limited) for the indented Items.

**Valid Enlistment document from EIL** (Engineers India Limited) for the relevant items in the tender to be submitted along with bid.

In case of an authorized dealer, the bidder shall submit a valid e nlistment document of the represented pipe/tube manufacturing company from EIL for the items specified in the tender.

3. The Bidder or the Pipe/Tube Manufacturing company they represent shall have supplied Steel Pipes/Tubes as per ASTM A 106 /A 312/A 335 standards to any Petrochemical Industry/ Crude Oil Refinery directly or through project consultant (s) in the last ten years counting from the date of Tender closing.

Vendor's action: Bidder is required to submit relevant Purchase order copies and Invoices / Inspection Release Notes or any other such documents in proof of meeting this requirement.

\*Bidder shall be considered eligible for all quoted items if they submit Purchase Order copies of alloy steel pipes/tubes. Otherwise shall be considered for only i ndividual category of items, for example Stainless Steel or Carbon Steel pipes/t ubes, as per PO copies provided.

Please Note: All the supporting documents supplied by Vendor to meet the Bid qualification Criteria **shall be Notarized.** 

## **Bid Rejection Criteria:**

- 1. The bid shall be rejected if the Bidder fails to provide supporting documentati on substantiating their claim as Manufacturer or an Authorized dealer of Steel P ipes/Tubes as per NRL specification along with the bid.
  - 2. The bid shall be rejected if the Bidder fails to provide valid enlistment doc ument as mentioned in BQC clause.
- 3. The bid shall be rejected if the Bidder fails to submit supporting documents, s uch as relevant Purchase order copies and Invoices / Inspection Release Notes or any other such documents for supply of Steel Pipes /Tubes as per ASTM A 10 6 /A 312/A 335 standards to any Petrochemical Industry/ Crude Oil Refinery dir ectly or through project consultant(s) in the last ten years counting from the d ate of Tender closing.

## **Key Topics:**

- **Bid Opening and Validity:** It was outlined that the bid opening details, including the bid end date of 20 June at 17:00, a bid validity of 90 days, and the absence of exemptions for start-ups and MSM Es. The bid will move to a reverse auction with the highest price bid elimination.
- **Bid Submission Requirements:** It was detailed about the bid submission requirements, including the need for bidders to submit CPS being 3% of the total GeM contract value & and WBG. It was als o mentioned that the Make in India and MSE purchase preferences is applicable to the tender.
- **Technical and Financial Bid Evaluation:** It was explained regarding two bid -evaluating technica I and financial bids, including the publication of technically qualified bidders on the tender portal and the allowance for bidders to raise representations within three days of the techno-commercial bid evaluation.
- **Bid Qualification Criteria:** It was presented regarding the bid qualification criteria, including the need for authorized dealers to submit dealership certificates and manufacturers to provide ISO cert ificates, factory licenses, or NSIC certificates. It was emphasized regarding the importance of notari zing all submitted documents.
- **Technical Specifications Clarification:** One participant viz. HEAVY METAL & TUBES raised conce rn about the lack of technical specifications for certain items in the bid document. From NRL side, t he issue was acknowledged and agreed to upload the missing long text descriptions in a corrigend um.
- **Fin Tubes Query:** One of the participant, Mr. Ashutosh from aksharfintubes, inquired about the in clusion of fin tubes in the BOQ. Technical team from NRL side confirmed that fin tubes are included and provided the serial number for reference. Ashutosh expressed concerns about the high cost of manufacturing a single tube under IBR.
- **DM&ISP Policy:** It was explained that the DM&ISP policy is applicable to the tender, which aims to give preference to domestically manufactured steel products. Bidders are required to submit an un dertaking as per the format provided in the tender.
- **Meeting Conclusion:** Finally, the key points discussed in the meeting was summarised, including the publication of a corrigendum and the applicability of the DMSP policy. It was confirmed that ther e were no further queries and the pre-bid meeting was closed.

Details of specification of each items are included in the revised ATC. Also diagrams are included in the new ATC.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
