Subject job is a work contract and is not covered under the Public Procurement policy for MSEs

The intending bidders for above tender should meet all the qualification criteria given below:

A) Past Experience of having **successfully completed** similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:

- **One** similar work costing not less than **Rs.28.73 Lakhs**
- **Two** similar works costing not less than **Rs.22.98 Lakhs each** and
- **Three** similar works costing not less than **Rs.17.24 Lakhs each.**

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the last bid submission date.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:** The contractor should have experience in minimum **any of the two jobs (among three)** mentioned below in Central Govt.org/State govt. org/Govt. PSU/or any other govt. organization within last 10 years as on tender floating date of tender.

(i) Minimum 2 years' experience in electrical renovation job.

(ii) Experience of supply, installation, testing and commissioning (SITC) of at least 1 set of LV/MV/HV panel/switchboard/feeder pillars.

(iii) Design, Manufacturing & Supply of at least 1 set of LV/MV/HV panel/switchboard

Note: **The vendor is liable for the rejection if any one of the above certificates and the technical data sheet filled with duly sealed and signed is not furnished with the Tender Document**

B) AVERAGE ANNUAL TURNOVER : During the last 3 financial years, shall be at least **Rs.17.24 Lakhs.**

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers and certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate

The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
