Pre-Qualification Criteria: The following PQC shall be complied:

- Bidder should be either a manufacturer or a dealer having experience in supplying non metallic octane Booster to any Indian petroleum oil company. In case the bidder is a dealer, he must submit a certificate of authorized dealership from the manufacturer.
- The product intended to be supplied should have US EPA certification.
- Bidder must quote for both the options as per BOQ i.e. FOR NRL site as well as Ex-Works basis.

Sample: Bidder must send a sample (500 ml) of the Octane Booster for evaluation at the time of bid submission or earlier as per convenience. However the sample should reach the address as specified below within 10 days from opening of the Technical bids, beyond which no sample will be considered for evaluation. Bidder should send sample accordingly considering the transit period up to NRL site & ensure that sample shall reach NRL site within the mentioned period.

NRL shall not be responsible for loss of sample in transit. Bidder may send their representative to witness the testing in our lab during the evaluation of their sample.

Special Note to Bidder:

a. The bidders have to quote their price for both the options as per BOQ as bellow otherwise wise offer shall not be considered for evaluation:

- ❖ OPTION 1: FOR NRL basis (door delivery) indicating Freight & transit insurance separately in the BOQ.
- ❖ OPTION 2: Ex-works basis & in that case transportation shall be in NRL scope including transit insurance. But all the activity involved for loading of tankers shall be in vendor's scope.
- ❖ Bidder has to quote in INR only

b. EVALUATION & ORDER AWARD:

- ❖ Evaluation shall be carried out as per BOQ considering both the options together on overall basis which shall be evaluated based on quoted rate multiplied by loading factor finalized based on dosing rate with loading of taxes, duties and other charges as applicable & single L1 bidder shall be decided & ARC (Annual Rate Contract) shall be placed for both the options to a single L1 bidder. Bidder has to quote for both the options which are mandatory for evaluation. Vendors have to necessarily quote (must offer) considering the minimum 100% of the required quantity as per tender. Otherwise their bids will not be considered.
- ❖ However, NRL may decide to distribute the tendered quantity amongst L1 and L2 bidders in the ratio of 80:20 provided L2 bidder matches the price of L1 bidder (considering loading factor as per tender)
- ❖ Release order shall be placed against the ARC for either OPTION 1 or OPTION 2 based on NRL requirement on time to time basis.
