Reasons for Rejection:

1. Bidder: M/S BRS Engg. Works

- o Reason 1: As per work order no: 4300024047-DIN/11.05.2011 in which the Executed Value is Rs. 1366377.89/- as on 30.06.2013 i.e. on the actual closing date, the total executed value on considering escalation 7% @ simple rate till May 2019 comes out to be Rs. 1940256.6/- which is below the minimum work costing limit of Rs. 25.55 Lacs for one similar work as per the subject tender.
- O Reason 2: As per work order no: 4300033875-DIN/01.11.2013 the bidder lacks experience in the PQC compliance which states that "The bidder must have Experience in AMC nature of Mechanical Maintenance works including rotary equipment & other mechanical equipment in Petroleum & Petroleum Installation or Chèmical or Fertilizer Industries". The nature of experience of AMC as submitted here is for Instrumentation System only.

2. Bidder: Manish Ray and Company

O Reason – 1: As per work order no: 4300020947-RAK/16.07.2010, the bidder lacks experience in the PQC compliance which states that "The bidder must have Experience in AMC nature of Mechanical Maintenance works including rotary equipment & other mechanical equipment in Petroleum & Petroleum Installation or Chemical or Fertilizer Industries". The nature of experience of AMC as submitted by the bidder is for Up-Keepment /Maintenance of Electrical Equipment at Siliguri Marketing Terminal only. Hence cannot be technically accepted for consideration in this tender.

3. Bidder: M/S Samar Paul

o Reason – 1: As per work order no: 24200373 against public tender no: WBSO/ENG/13-14/PT-01, in IOCL, the value of mechanical works comes out to be Rs. 1084137.22/- considering escalation of 7% at simple rate for 4 years from the date of completion. This amount doesn't meet the minimum work costing amount of Rs. 25.55 lacs for only one similar work as per the subject tender. Also, no other tender have been submitted by the bidder for evaluation. Hence the bidder doesn't qualify the criteria of minimum work costing in similar works.
