PRE-QUALIFICATION CRITERIA:-

The intending bidders for above tender should meet all the qualification criteria given below:

- A) Past Experience of having successfully completed similar works* during last 10 years in any hydrocarbon refinery (ending last day of month previous to the one in which applications are invited) should be either of the following:
 - ➤ One similar work costing not less than Rs.185.87 Lakhs
 - > Two similar works costing not less than Rs.148.69 Lakhs each and
 - ➤ Three similar works costing not less than Rs.111.52 Lakhs each.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month preceding month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

*Similar Works:

1. Similar jobs mean inspection of equipment including both internal & external inspection, thermal imaging and safety surveillance activity including housekeeping and safe working at height by using Unmanned Aerial Vehicles (Drones), data analysis under various categories of HSSE using AI.

However, the above-mentioned requirement of prior turnover and prior experience will be relaxed if the bidder is Micro and Small Enterprise or Startup and meets the quality and technical specifications described in the tender, subject to submission of valid supporting documents by the bidder.

2. The Bidder shall not be on the Holiday List of NRL / Any Other PSU or government Organization in India and shall submit the declaration for the same.

B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs.111.52 Lakhs.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers and certification of annual turnover for the last three financial years from a registered chartered accountant firm. Last three 3 financial years mentioned above refers to immediate 3 preceding financial years wherever the last bid submission date is after 30th Sept. In case of tenders having last bid submission date up to 30th September, and audited / CA certified turnover documents of the preceding financial year is not available, the audited / CA certified turnover documents of the 3 years prior to preceding financial year will be considered. Bidders are advised to go through instructions provided as 'Instructions for online Bid Submission' provided in the next page.
- 2) Bidders can access tender documents from the website, fill them with all relevant information and submit the completed tender document into electronic tender on the website www.gem.gov.in.
- 3) Tenders and supporting documents should be uploaded through e-procurement portal only. Hard copy of the tender documents will not be accepted.

Both Technical bid and Financial bid are to be submitted concurrently, duly digitally signed in the web site www.gem.gov.in

Online Bids are received only on GeM website www.gem.gov.in on or before due date as indicated in the NIT. The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
