Buyer Added Bid Specific Additional Terms and Conditions

1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added text based ATC clauses

A. PRE-QUALIFICATION CRITERIA:

- Bidder shall be manufacturer of Double seal for floating roof Tank or Authorised dealer with valid dealership certificate. Bidder shall submit License/certificates and catalogues/brochures indicating their manufacturing & testing facilities in above requirement.
- Bidder shall have manufactured/Supplied double seal other than Foam seals for at least one hydrocarbon tank of minimum 20M diameter during last Ten years to any Oil hydrocarbon industry either directly or through PMC. Bidder shall submit suitable Work Order copies along with other documents to substantiate satisfactory completion of the Work Order viz. IRN/Invoice/Challans/Completion certificate etc. as a proof of experience.
- Bidder shall have valid ISO certification for manufacturing facilities and quality management. Bidder shall submit copies of valid ISO certificates in support of the same.

Since as per GSR 186 E Ministry of Environment and Forests Notification 18thMarch 2008 CPCB Compliance Report. Primary Seal shall be Liquid or Shoe Mounted for EFRT and Vapor Mounted for IFRT. In the enquiry you have mentioned Liquid Mounted Mechanical Shoe Seal with Sec, Seal. For IFR Tank Vapour Mounted Mech. shoe Seal is to be consider as per CPCB Norms. As such we will consider Vapour Mounted Mechanical Shoe Seal with Gasketed type Secondary Seal. Kindly note & confirm type of seal. we require Deck Height , Deck Submergence under Normal working Condition & Rim Gap as Drawing attached with the Technical Data Sheet is not clearly Visible.
