EVALUATION OF THE TENDER:

Evaluation of this tender shall be done separately for Group-A & Group-B. Basis of evaluated of each group shall be on 'Overall lowest offer basis'. Bidders are requested to quote price for Group-A and/or Group-B as per prescribed Price Schedule Formats (in Excel Format) enclosed with tender. Additionally, bidders need to upload price break-up of commissioning spares & special tools & tackles, mandatory spares and also 2 years O&M spares along with their priced bid as per instruction provided in tender.

6.0 <u>DOCUMENTS TO BE UPLOADED AS A PART OF PART - I : TECHNO-</u>COMMERCIAL / UNPRICED E-BID:

- a) Documents in support of PQC of the tender.
- b) Complete Technical documents duly filled, signed & stamped.
- c) Agreed Terms & Conditions (ATC) duly filled, signed & stamped. The commercial terms & conditions should not be repeated in the offer.
- d) Bidder's Self-Declaration of black listing/ holiday listing as per Performa enclosed duly signed & sealed.
- e) Format for declaration for not being under liquidation, court receivership or similar proceedings.
- f) Integrity Pact duly signed & sealed.
- g) In case of Micro & Small Enterprise (MSE), bidders need to upload a copy of UAM / EM (Part-II) certificate for availing MSE benefit against the tender. Applicable for Indian Bidders only.

9.0 OFFER VALIDITY: 120 days from the final bid due date.

10.0 **GENERAL**:

- 10.1 If the service portion (i.e. Site work & Supervisory services) is to be done by any Indian counterpart, it shall be quoted only in Indian Rupees. A separate service PO shall be placed on the Indian Counterpart for the service portion based on the request from overseas OEM. However, Single Point Responsibility for execution of the complete job of the tender (including Site work & Supervisory services) shall be with overseas OEM only.
- In case of Foreign Bidder, if any of the documents in support of meeting PQC are not in English language, then the English translation copy of the same duly certified, stamped and signed by Local Chamber of Commerce shall be furnished along with the document in the un-priced bid.
- 10.3 Consortium/Joint venture bids shall not be accepted.
- In this tender, either the Indian Agent/ Authorized representative in India on behalf of the foreign Principal (i.e. OEM) or foreign Principal (i.e. OEM) can bid but both cannot bid in the same tender. No Foreign Principal can engage/ authorize more than one Indian Agent/ Authorized representative in India.
- In order to consider offer submitted by Indian Agent/ Authorized representative in India on behalf of Foreign Principal (i.e. OEM), Foreign Principal (i.e. OEM) must meet the BQC requirement of the Tender. Single Point Responsibility for execution of the complete job (as per scope of tender) shall be with Foreign Principal (i.e. OEM) only.
- 10.6 Canvassing in any other form by the bidder or by any other agency on their behalf may lead to disqualification of their bid.
- In case any of the document/information(s) furnished by a bidder are found to be false/forged, such bidder shall be kept in holiday list/ black list apart from other penal actions as deemed fit by NRL.
- In case any bidder is found to be involved cartel formation, his bid will not be considered for evaluation/placement of order. Such bidder will also be debarred from bidding in future.
- 10.9 EMD is not applicable for this Tender.
- Any modification of the Bidding Document, which may become necessary as a result of the bidder's query/ pre-bid discussion, shall be published in e-tendering portal (http://eprocure.gov.in/eprocure/app) through the issue of an Addendum/ Amendment/ Corrigendum/Clarifications.
