Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Annual rate contract for building maintenance , water supply and other civil / structure jobs at NRMT and CCU, NRL site.
Tender No. & Date :	OC19000324 dtd. 08.06.2022
Due Date of Submission:	Before 11.00 AM of 21.06.2022.
Earnest Money Deposit:	Rs.1,00,000.00
Contract Period:	02 years from the date of site handover.

PRE-QUALIFICATION CRITERIA:-

A) **Past Experience** of having **successfully completed** similar works* during last 10 years (as on the last day of the month preceding the last bid submission date) should be either of the following:

- **One** similar work costing not less than **Rs. 124.99 lakhs**
- **Two** similar works costing not less than **Rs. 99.99** and
- **Three** similar works costing not less than **Rs. 74.99**.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month preceding the last bid submission date.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

Similar Works: The bidders should have experience in executing "Project / Maintenance nature of Civil Works in Hydrocarbon Refinery/Petrochemical/Fertilizer Industry". (contract involving solely or in combination amongst any of the following category of works shall not be considered: Earthwork, site grading ,horticulture , Jungle cutting ,drain cleaning, material supply ,manpower supply, housekeeping jobs, machinery operation ,painting ,insulation, refractory, waterproofing, fireproofing jobs).

B) **AVERAGE ANNUAL TURNOVER** : During the last 3 financial years, shall be at least **Rs. 74.99**

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
