Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

Name of Work:	Annual Rate Contract (ARC) for miscellaneous civil works under NRL Township department for Group (A) & Group (B)
Tender No. & Date :	OC20000395/DEV dated 07.06.2024
Due Date of Submission:	Before 11.00 AM of 21.06.2024
Earnest Money Deposit:	Rs.1,76,000
Contract Period:	36 months from the date of site handover. If the quantity exhausts before the end of contractual period, the contract shall be closed.

PRE-QUALIFICATION CRITERIA:-

The subject job being 'Work Contract', therefore, the relaxation pertaining to Prior turnover, prior experience and price benefit shall not be applicable for MSE and Start up bidders for this tender. Pre-Qualifying Criteria (PQC) mentioned in the tender must be complied by all participating bidders.

The intending bidders for above tender should meet all the qualification criteria given below:

A) Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which the original bid due date falls, should be either of the following:

- **One** similar work costing not less than **Rs.44.03 Lakhs**, or
- **Two** similar works costing not less than **Rs.35.22 Lakhs each**, or
- **Three** similar works costing not less than **Rs.26.42 Lakhs each**.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which the original bid due date falls.

Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:** Successfully completed any 1. Civil maintenance nature job or 2. Civil Renovation job or 3. New Civil construction job or 4. Civil rate contract job

B) AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs.26.42 Lakhs

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate

The bidder shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Technical Bid. Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
