#### 3.1 Background:

NRL has a capacity of producing 50 TMT of Paraffin Wax and 4.5 TMT of Semi-Micro Crystalline Wax Annually. The liquid wax is moulded into slabs of 5 kilograms and is packed into pallets of 1.35 Tonnes at the Automatic Slabbing Packing Unit (ASPU). There are two cold rooms at ASPU which are to be maintained at a colder environment to obtain an enhanced rate of wax slabs solidification. Two conveyor lines are used to transport the liquid wax inside the two cold rooms respectively. The solidified slabs are then transported and packed in two separate packaging lines. The combined rated capacity of the two conveyor lines is 200 Tonnes per day. The unit remains in continuous operation throughout the day.

### 4.0 Aims & Objectives:

The objective of the analysis and re-engineering of the Refrigeration package is to achieve greater reliability in terms of performance of the system so as to meet the required design capacity of the plant with optimal modifications in the existing system.

## 5.0 Venue & Deadline for submission of proposal

Proposal, in its complete form in all respects as specified in the EOI, must be submitted to NRL at the address specified herein earlier. In exceptional circumstances and at its discretion, NRL may extend the deadline for submission of proposals by issuing an amendment to be made available on the NRL website, in which case all rights and obligations of NRL and the vendors previously subject to the original deadline will thereafter be subject to the deadline as extended.

- c. Vendors must visit NRL site at their own cost to have an idea about the refrigeration package and the troubles faced by NRL in the operation and maintenance of the package.
- d. The vendors shall be required to make a presentation to a committee show-casing their proposals.
- e. Only the short listed applicants shall be eligible to participate in an ensuing tender to be evaluated on "Lowest Offer Basis".

## TERMS OF REFERENCE

#### 1. BACKGROUND

NRL has a capacity of producing 50 TMT of Paraffin Wax and 4.5 TMT of Semi-Micro Crystalline Wax Annually. The liquid wax is moulded into slabs of 5 kilograms and is packed into pallets of 1.35 Tonnes at the Automatic Slabbing Packing Unit (ASPU). There are two cold rooms at ASPU which are to be maintained at a colder environment to obtain an enhanced rate of wax slabs solidification. Two conveyor lines are used to transport the liquid wax inside the two cold rooms respectively. The solidified slabs are then transported and packed in two separate packaging lines. The combined rated capacity of the two conveyor lines is 200 Tonnes per day. The unit remains in continuous operation throughout the day.

The refrigeration package exists to maintain a suitable temperature inside the two cold rooms such that the solidification of wax slabs is at an optimum rate. The rated capacity of the refrigeration package is 1209.3 KW. Further details of the system are delineated herein:

Duty: ContinuousCapacity: 1209.3 KW

• Driver: Electrical Motor (560 KW)

• Refrigerant: R134a

• Compressor Type: Oil Injected Screw

• HP Receiver Capacity: 5 m<sup>3</sup>

# 2. OBJECTIVES

The objective is to analyze and determine the root cause of insufficient cooling of the system and suggest modifications of the existing refrigeration package so as to obtain greater reliability. The existing system is unable to maintain the optimum temperature inside the cold rooms. NRL has been facing issues with insufficient/uneven cooling in both the conveyor lines. The two cold rooms contain four evaporators each and desired cooling effect in all the evaporators cannot be achieved at one time and always require manual intervention.

It is thereby proposed to carry out a detailed analysis of the existing system and carry out necessary re-engineering and modification of the existing package. All modifications, testing, supply of materials/equipments, supervision for installation/replacement of parts/equipments, and commissioning of the modified package is to be carried out. The parties selected through the EOI shall only be eligible to participate in a competitive bidding.

# 3. TERMS OF REFERENCE

The terms of reference of the exercise are:-

- (a) To analyze the installed refrigeration package in terms of its design and actual performance.
- (b) To analyze the heat demand of the system.
- (c) To re-engineer the package in an effective and efficient manner such that minimal modifications/replacement of parts/equipments are generated.
- (d) To reduce manual intervention in the system.
- (e) To supply and install the parts/equipments and commission the modified package.
- (f) To guarantee the performance of the modified system for continuous operation during the year.

### 3. METHODOLOGY

Vendor has to visit NRL site and carry out a detailed analysis of the existing system. The vendor has to interact with the Operation and Maintenance personnel of NRL who will provide all available inputs related to the existing system.

The package is to be re-engineered is such a way that the modifications in the existing system are kept at a minimum.

The supply of the modified parts/equipments and commissioning shall be the responsibility of the vendor. Vendor has to submit a detailed time schedule for carrying out the study, supply of materials and commissioning.

# 4. <u>TIME SCHEDULE</u>

Time being the essence of this assignment, the entire assignment of detailed analysis, re-engineering, modification, supply and installation supervision—of the recommended Equipment/parts and commissioning of the refrigeration package of Automatic Slabbing and Packing Unit needs to be completed within 06 months of placement of Purchase Order (PO)

# 5. <u>INPUTS TO BE PROVIDED BY NRL</u>

NRL will facilitate interaction of agency/individuals/service engineers with the Operation & Maintenance teams of the Automatic Slabbing Unit. NRL shall provide all the available process parameters and data sheets. All parameters sought by the party may not be available with NRL and in such a scenario; the party has to calculate the required parameters by itself.

## 6. <u>DELIVERABLES</u>

- (i) Analysis of the existing system and submission of detailed report including the recommendations to increase the reliability of the system to the required level.
- (ii) Framing of modified P&IDs in discussion with NRL.
- (iii) Conduct and submit the HAZOP report.
- (iv) Supply and installation supervision of the recommended parts/equipment.
- (v) Commissioning of the new system.
- (vi) Conduct Performance Guarantee Test Run of the modified system.
- (vii) To submit the operation and maintenance manual for the system.
- (viii) Supply of commissioning spares and mandatory spares.
