- 1) **Description of EOI:** Purchase of high land of 3 - 4 bigha by NRL near Raw Water Intake of NRL.

Offer may be sent by post also but has to reach on or before the above schedule. For any delay in receipt of the offer due to reasons of the post or courier NRL shall not be responsible.

- 3) **Type, Size and Location of Land:** The size of the plot of land should be minimum 50M width with rectangular/square shape and it should be high land adjacent to NRL's Raw Water Intake sub-station complex.
- 4) **Location of land:** The location of the land shall at the river bank of Dhanshiri River near to the Raw Water Intake Sub-station and intake pile line corridor.
- 5) **Bidding Process for EOI:** It is preferred that a single bidder offers EOI for the plot of land with size of 3-4 bigha which is adjacent to the Raw Water Intake in a location as described above. However, in case if one bidder does not have sufficient land of that size then more than one bidder can offer their plots jointly to make the size as described above and the EOI shall be jointly submitted by the bidders.
- 6) **Selection of Successful Bidder and Issue of Tender:** NRL will inspect land of the bidders submitted the EOI to shortlist the plots that fulfills the requirement of NRL as mentioned in the above clauses. Selected shortlisted bidders shall be issued tender paper for submission of their Commercial Offer and other terms & conditions in a later date which will be intimated to the bidders in due course of time.
