3) **Quantity and Type of Accommodations**: The house property should contain 2BHK / 3BHK type family accommodation house purpose with rooms having attached bathrooms, kitchen, parking space, etc.

Preference will be given to the properties located in the same campus/ boundary.

- 4) **Locations of property**: The locations of the house properties should be in Golaghat, Bokakhat, Numaligarh, Doigrung, Kanaighat, Telgaram. However, any other location up to maximum of 15KM by road from refinery Main Gate may also offer their properties.
- 5) **Age of the property**: The age of the house property should not be more than 10 years. The property under construction and likely to be completed within 1 year from the date submission of the EOI also may participate in the EOI.
- 6) **Road connectivity**: The house property should be well connected with motorable road.
- 7) **Security**: The campus should be well secured with boundary wall and gates.
- 8) **Garage**: Provision of covered and secured garage for cars suitable for SUV against each house/flat should be available.
- 9) **Utilities**: The houses should have facility for 24x7 running potable water and electricity.
- 10) **Fittings & Fixtures**: Each unit should be fully fitted with all electrical fittings like tube lights, ceiling fans, lights, geysers, chimney, exhaust fans, etc. The bath rooms should have good quality WC, Wash Basins, taps, overhead shower, wall mixers, etc.
