TECHNICAL EXPERIENCE CRITERIA: -

Bidder shall be an established Indian Manufacturer and the offers of Bidders fulfilling all the qualification criteria as mentioned below will be considered for further technical evaluation.

- a. Bidder should be an established Indian Manufacturer of cables as per relevant BIS/ IEC Standards and shall have a valid BIS certificate/license for manufacturing of power cables and shall be manufacturing FRLS HV cables up to a minimum cross of 1C x 630 sq.mm (33/33 kV grade) and 3C x 300 sq.mm. (6.6/6.6 kV grade). Active BIS License and Purchase order references in this regard shall be submitted by the bidder. The BIS License shall be active/valid as on original bid due date.
- b. Bidder should have supplied 100 KM (min.185 sq.mm size and 6.6 kV voltage or higher) of cable to Oil Refinery / Petrochemical / Oil & gas processing units in one PO reference during last 10 years from the date of opening of technical bid for HV Power cables in line with IS/IEC requirements and shall meet as per given technical specification & data sheet as applicable.

In case the above parameters are not available from a single past reference, maximum of two references may be cited to satisfy the above qualification requirements. Single Purchase order or Maximum of two purchase order references from Oil Refinery / Petrochemical / Oil & gas processing units along with Inspection Release Note / Invoice copy shall be submitted by the bidder in this regard.

c. Bidder should have their own manufacturing facility with adequate capacity to manufacture the cable of 33kV voltage rating. Active BIS License in this regard shall be submitted by the bidder. The BIS License shall be active / valid as on original bid due date.

- d. Bidder must have complete testing facilities to perform acceptance and routine test as per relevant IS. A Declaration in this regard shall be submitted by the bidder in their Company Letterhead.

Type test for cables shall be performed as per IS 7098 from CPRI / ERDA lab or in-house NABL accredited facility in presence of TPI personnel as per statutory guidelines & IS/IEC standards without any time/cost implication. A Declaration in this regard shall be submitted by the bidder in their Company Letterhead. In case of tests being conducted in in-house NABL accredited facility, Bidder shall also submit NABL Accreditation Certificate.

The Average Annual Turnover of Bidder shall be equal to or more than INR 23,08,73,000/- (Indian Rupees Twenty-Three Crores Eight Lakhs And Seventy Three Thousand Only) during preceding 3 (Three) Financial Years.

- a. Notwithstanding any other condition / provision in the tender documents, bidders are required to submit complete documents pertaining to Qualification Criteria along with their offer. Evaluation may be completed based on the content of the Bid itself without seeking any subsequent additional information, which may result in rejection of Bid. NRL/MPMC at its discretion, may request bidder to submit the necessary information or documentation, within a reasonable period, to withdraw deviation, reservation, or rectify omission in the bid related to documentation requirements. However, Bidder shall not be allowed to submit new references or document related such new references with respect to their experience unless it is not mentioned in their original offer.
- b. Submission of authentic documents is the prime responsibility of the Bidder. However, NRL/MPMC reserves the right to get the document cross verified, at their discretion from the document issuing authority. c. In case any other document is submitted by Bidder in support of execution, the same shall be subject to acceptance by the OWNER or its representative.

If the Bidder cites any reference of a job executed for OWNER or executed for some Client through Consultant and the vendor is not able to furnish documentary evidence, the internal records of OWNER or Consultant (as the case may be) shall be considered.

Verification of BQC Documents

Verification of BQC credentials (Past experience) may be taken up with issuing authorities for L1 Bidder. The verification procedure shall be initiated immediately upon establishing L1 and order shall be placed only after the completion of verification.

In case of verification, where authenticity of BQC documents could not be established, a team comprising of NRL/MPMC may visit the issuing authority for obtaining the same directly from them.

Despite all checks, if the verification could not be completed or any fraud takes place, the tender shall be annulled. In that case such Bidder shall not be allowed to participate in the future bidding process. Penal actions shall be taken in case of frauds in line with the provisions of Bidding Document and Banning Policy of NRL / MPMC.

Moreover, the Bidder's organization shall be responsible for any and all actions of their Employees and any claims seeking to pin-point the blame on some Employee of Bidder and attempting to absolve the Bidder's organization shall not be entertained.
