## PRE-QUALIFICATION CRITERIA

- **A) Past Experience** of having **successfully completed** similar works\* during last 10 years (as on the last date of the month preceding the last bid submission date) should be either of the following:
  - ➤ One similar work costing not less than = Rs.13.76 Lakhs
  - ➤ Two similar works costing not less than = Rs.11.01 Lakhs each and
- ➤ Three similar works costing not less than=Rs.8.26 Lakhs each.

\*Similar Works: Bidder should have professional knowledge and experience of digital printing and display board fixing job using FRP sheet. The bidder has to submit copy of work order and corresponding completion certificate as proof of experience.

Note: Relevant work order copies and completion certificates are to be enclosed with offer. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

- B) AVERAGE ANNUAL TURNOVER: During the last 3 financial years, shall be at least Rs.8.26 Lakhs.
- C) Possession of Valid GST registration certificate
