- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.
- 3. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- 6. Reverse Auction would be conducted amongst all the technically qualified bidders except the Highest quoting bidder. The technically qualified Highest Quoting bidder will not be allowed to participate in RA. However, H-1 will also be allowed to participate in RA in following cases:
 - i. If number of technically qualified bidders are only 2 or 3.
 - ii. If Buyer has chosen to split the bid amongst N sellers, and H1 bid is coming within N.
 - iii. In case Primary product of only one OEM is left in contention for participation in RA on elimination of H-1.
 - iv. If L-1 is non-MSE and H-1 is eligible MSE and H-1 price is coming within price band of 15% of Non-MSE L-1

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Pre-Qualification Criteria:

The following documents should accompany the Technical Bid.

- 1. The bidder must be an authorized supplier or manufacturer of LIDAR.
- 2. The bidder must have supplied Lidar/laser-based instruments for similar projects in last ten years (from the date of bid due date).
- 3. The bidder must be compatible enough for carrying out maintenance of LIDAR machine and its compone nts

Bidder shall submit following documentary proof in support of PQC:

- 1. Detail about the company as a distributor or manufacturer of LIDAR.
- 2. Copies of Work Order and Installation certificate of Lidar/laser-based instruments or similar products.
- 3. A Valid ISO certificate.
- 4. Manufacturer Authorisation certificate specific to this tender/RFQ. (General authorisation certificate will not be acceptable)
- 5. Proof of a minimum of one crore annual of turnover in each of the last 2 financial years. Audited financial statements in this regard needs to be submitted

Here "similar projects" means Measurements with Lidars and Laser-Based Instruments

<u>Deliver Schedule:</u> The complete systems should be supplied in not more than 10 weeks from the date of issue of Purchase Order; delay may lead to cancellation of the Order/penalty.

NRL will procure the LIDAR machines in a phased manner. Initially work order for one LIDAR machine will be placed. NRL will have the right to procure the second LIDAR machine at its discretion for a period of one year based on satisfactory performance of the first LIDAR

Payment clause:

Payment will be made only after successful Certification from NRL EIC, in the following steps.

- **85% payment** of the total order value after Supply, Installation and Commissioning of the LIDAR.
- **5% payment** of the total order value after completion of one year of sustained operation of the LID AR. However, this payment will be subjected to deduction of any penalty amounts accumulated during the first year
- 5% payment of the total order value after completion of two years of sustained operation of the LI
 DAR. Similarly, this payment will be subjected to deduction of any penalty amounts accumulated du
 ring the second year
- Balance 5% payment of the total order value after three years of sustained operation of the LIDAR.
 This payment will be subjected to deductions for any penalty amounts accumulated during the third year.

Penalty Deductions:

- 1. The deduction of penalty amounts shall be confirmed and verified by the NRL Engineer in charge based on the duration of the delays in maintenance.
- 2. By submitting a bid for this tender, the bidder acknowledges and accepts the payment terms and penalt y clauses mentioned in this document.

Penalty:

The successful Bidder must ensure prompt services and maintenance within the warranty period of three y ears. To ensure timely maintenance and efficient performance of the Lidar machine, the following penalty clauses shall be applicable:

- **Remote Mode/ Online Maintenance**: In the event of a reported malfunction, the bidder shall attend to the equipment in remote mode within 72 hours (including weekends) from the time of malfunction reporting. Failure to do so will result in a penalty of Rs. 5000 per day, levied for each day beyond the initial 72-hour timeframe.
- Physical Mode/ Offline Maintenance: If the LIDAR machine requires physical attention from the site, the bidder shall report on-site within 120 hours (including weekends) from th e end of Remote Analysis Window on the need for site visit. Any delay beyond this speci fied 120-hour timeframe will result in a penalty of Rs. 5000 per day, levied for each day ex ceeding the designated period.
- * The site of physical reporting will be **Guwahati, Assam**.
- * The **annual cumulative penalty amounts** shall be deducted from the respective payment milestones mentioned in payment clause. The deduction of penalties shall be confirmed and verified by the NRL Engin eer in charge.

<u>Supply and Installation:</u> The entire system, referred to as Equipment, comprising Lidar, accessories, sof tware, container, protective enclosure, camera must be quoted for and supplied as a complete unit; quotat ion or delivery of a part of the system shall not be accepted.

<u>Training:</u> The successful Bidder shall have to train a designated team on the functioning of the Lidar and the accessories for at least five working days at their own expenses at Guwahati/Jorhat.

<u>Certification</u>: Certification will be done by the Project Monitoring Committee post installation and training subject to receipt of telemetric wind data in prescribed format for at least five days.

Validity of the Bid: The price bid should be valid for at least 1 year from the date of submission

PBG: Performance Bank Guarantee against the contract shall be 10% of the total purchase order value an d will be valid till completion of three years from the date of delivery of goods at respective consignee loca tion with claim period of 06 months.

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

5. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses

on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
