Two parts ONLINE bid (E-tender) offers are requested from competent bidders for following work:

PRE-QUALIFICATION CRITERIA:-

The subject job falls under the category of public safety, health, critical security operation and equipment's etc. Hence, there will be no relaxation pertaining to 'prior turnover' and 'prior experience / technical requirements' for MSE and 'Start Up' bidders in this tender.

A) Past Experience of having **successfully completed** similar works* during last 10 years ending last day of month previous to the one in which applications are invited should be either of the following:

- **One** similar work costing not less than **Rs. 34.64 Lakhs**, or
- **Two** similar works costing not less than **Rs. 27.71 Lakhs each**, or
- **Three** similar works costing not less than **Rs. 20.78 Lakhs each**.

Note: Relevant work order copies and corresponding completion certificates are to be enclosed with offer. The completion certificate should consist of Name of Work, Work Order number & date, Actual executed value and Actual completion date. The value of past experience shall be adjusted at a simple rate of 07% for every completed year and / or part thereof ending last day of the month proceeding the month in which bids are invited.

Unless otherwise specifically mentioned in the tender, Provisional Job Completion Certificate or Job Completion Certificate issued against incomplete / in-progress job will not be acceptable.

***Similar Works:**

A) The bidder shall have experience in executing Electrical works up to 11KV in Public sector unit (PSU) of oil refinery/petrochemical complex/fertilizer complex in India. The bidder shall submit copy(ies) of relevant Work Orders(s) and Completion Certificate(s) in the un-priced bid in support of the above criteria.

B) Bidder should have a valid electrical contractor's license of minimum 11KV voltage level. Same should be submitted during bid submission.

B) AVERAGE ANNUAL TURNOVER, of the last 3 (three) financial years, shall be at least Rs.20.78 Lakhs #.

Bidders to submit copies of audited profit & loss account for the last three financial years in support of annual turnovers or certification of annual turnover for the last three financial years from a registered chartered accountant firm.

C) Possession of Valid GST registration certificate

Price Bids of only those bidders shall be opened who are Techno-commercially qualified, at a time and place for which notice shall be given. The qualified bidders shall be at liberty to be present either in person or through an authorized representative at the time of opening of the Price Bids with the Bid Acknowledgement Receipt.
